Charles Crosby deposes and states:

1. I am over the age of 18, and have personal knowledge of the matters stated herein.

2. I am a geologist for Mewbourne Oil Company ("Mewbourne"), and I am familiar with the geological matters involved in these cases. I have been qualified by the Division as an expert petroleum geologist.

3. These cases involve the Bone Spring formation underlying horizontal spacing units collectively comprising all of Sections 11 and 12, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico. Applicant proposes to drill four wells to depths sufficient to test the Bone Spring formation in the subject lands.

4. The following geological plats are attached hereto:

(a) Exhibit 3-A is a structure map on the base of the Second Bone Spring Sand. It shows that structure dips gently to the south-southeast. It also shows a west-east line of cross-section.

(b) Exhibit 3-B is a cross section showing the Second Bone Spring Sand, the target zone for the wells proposed in the well units. The well logs on the cross-section give a representative sample of the Second Bone Spring Sand in this area. The target zone in the sand is continuous and uniformly thick across the well units.

5. I conclude from the maps that:

(a) The horizontal spacing units are justified from a geologic standpoint.

(b) The target zone is continuous and of relatively uniform thickness across the well units.

(c) Each quarter-quarter section in each well unit will contribute more or less equally to production from a well.

(d) There is no faulting or other geologic impediment in the area which will affect the drilling of the subject wells.

6. Exhibit 3-A shows that Second Bone Spring Sand wells in the area are predominantly laydown wells. Mewbourne believes laydown well units are reasonable.

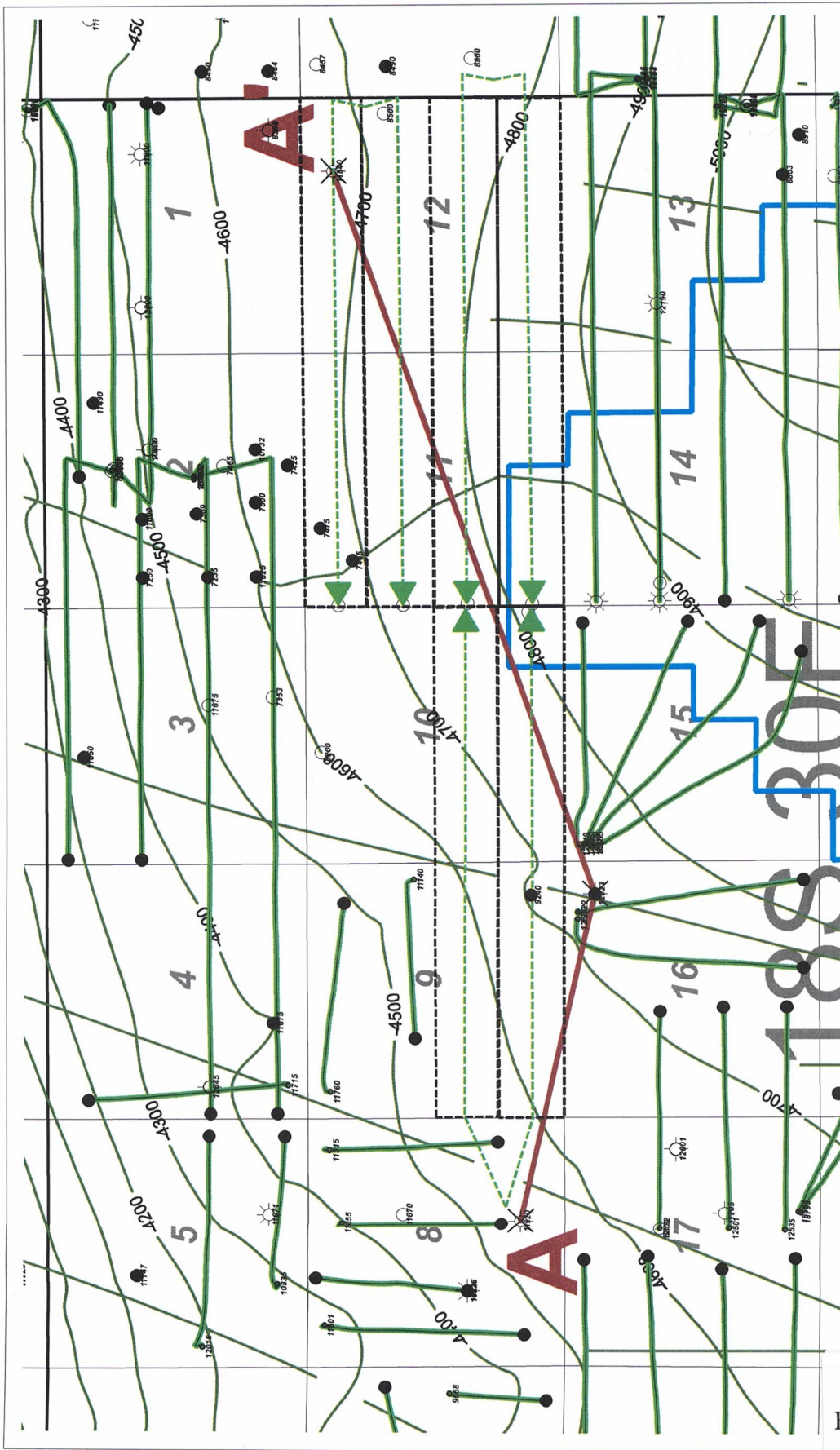
7. Exhibit 3-C contains horizontal drilling plans for the proposed wells. The producing intervals of the wells will be orthodox.
