**NOTICE OF WITHDRAWAL OF OBJECTION TO CASES**

Lario Oil & Gas Company (“Lario”), successor in interest to Avant Operating, LLC (“Avant”), which entered its appearance in the above-referenced cases on April 29, 2024, and subsequently withdrew its appearance on May 21, 2024. Lario, as successor in interest to Avant, hereby withdraws its objection to the above-referenced cases. Lario no longer opposes any of the above-referenced cases and withdraws from each of the cases.

In support of this withdrawal, Lario states as follows:

1. Avant entered its appearance in the above-referenced cases on April 29, 2024.
2. On May 21, 2024, Avant dismissed its competing applications filed in Case Nos. 23970-23971.

For these reasons, Lario seeks complete withdrawal of any entry of appearance, intervention, objections, or opposition to these cases proceeding by affidavit at the August 22, 2024 hearing.
