**UNOPPOSED MOTION TO AMEND THE PRE-HEARING ORDER**

Magnum Hunter Production, Inc. (“Magnum”), through its undersigned attorneys, moves the New Mexico Oil Conservation Division (“Division”) to amend that certain Pre-Hearing Order (“PHO”) issued in the above-referenced cases on July 26, 2024. In support of this motion, the following is shown:

1. The competing applications in the above-referenced cases cover the Bone Spring and Wolfcamp formations in the case’s subject lands, and the cases have been set for hearing on September 17, 2024, pursuant to the existing PHO.
2. Subsequent to issuance for of the PHO, Magnum filed additional applications in Case Nos. 24756, 24757, 24758 and 24759 for the Wolfcamp formation in the Subject Lands.

3. As directed by the Division, Magnum submits this motion to request that the PHO be amended to include the additional Wolfcamp cases (24756-24759). Except for the additional the Wolfcamp cases to be included, the PHO should remain the same.
