STATEMENT OF THE CASES

In Case No. 24751, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the NW/4 SE/4 and N/2 SW/4 of Section 25, and the N/2 S/2 of Section 26, Township 19 South, Range 30 East, Eddy County, New Mexico. The Unit will be dedicated to the **Morbucks 25-26 Federal Com 123H** well, which will be drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 25, to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 26.

In Case No. 24572, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the SW/4 SE/4 and S/2 SW/4 of Section 25, and the S/2 S/2 of Section 26, Township 19 South, Range 30 East, Eddy County, New Mexico. The Unit will be dedicated to the **Morbucks 25-26 Federal Com 124H** wells, which will be drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 25, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 26.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 23 miles northeast of Carlsbad, New Mexico.
