**STATEMENT OF THE CASE**

In Case No. 24768, Applicant requests that the Division pool additional uncommitted interests under the terms of Division Order No. R-23009. The Division entered Order No. R-23009 in Case No. 23667 on January 10, 2024. The order: pooled uncommitted interests in the Bone Spring formation underlying a standard horizontal spacing unit comprised of the S/2 NW/4 of Section 29 and the S/2 N/2 of Section 30, Township 18 South, Range 31 East, Eddy County, New Mexico (“Unit”); dedicated the Unit to the Long John 29-30 Fed Com 122H and Long John 29-30

Fed Com 132H wells (“Wells”); and designated Permian Resources Operating, LLC (OGRID No. 372165) as operator of the Unit and Wells. On May 15, 2024, the Division entered Order No. R-23009-A, which pooled additional interests under the terms of Order No. R-23009.

Since Order No. R-23009 and Order No. R-23009-A were entered, Applicant has identified additional uncommitted interests in the Unit that should be pooled under the terms of Order No. R-23009. Applicant requests that these additional interests be pooled into the unit to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands.
