#### **STATEMENT OF THE CASES**

In Case No. 24775, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 32 and 33, Township 20 South, Range 27 East, Eddy County, New Mexico. The Unit will be dedicated to the Ventura 3233 Fed Com 201H well, which will be drilled from a surface hole location in the SW/4 NW/4 (Unit E) of Section 32 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 33. This is a proximity tract unit. Therefore, the

completed interval of the Ventura 3233 Fed Com 201H well will be located within 330' of the quarter-quarter section line separating the N/2 N/2 and S/2 N/2 of Sections 32 and 33 to allow for the creation of a 640-acre standard, horizontal spacing unit.

In Case No. 24776, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 32 and 33, Township 20 South, Range 27 East, Eddy County, New Mexico. The Unit will be dedicated to the Ventura 3233 Fed Com 121H and Ventura 3233 Fed Com 131H wells, which will be drilled from surface hole locations in the SW/4 NW/4 (Unit E) of Section 32 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 33.

In Case No. 24777, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 32 and 33, Township 20 South, Range 27 East, Eddy County, New Mexico. The Unit will be dedicated to the Ventura 3233 Fed Com 122H and Ventura 3233 Fed Com 132H wells, which will be drilled from surface hole locations in the SW/4 NW/4 (Unit E) of Section 32 to bottom hole locations in the SE/4 NE/4 (Unit H) of Section 33.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
