STATEMENT OF THE CASES

In **Case No. 24795**, Mewbourne applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 480-acre, more or less, non-standard horizontal spacing unit comprised of the W/2 of Section 12 and the NW/4 of Section 13, Township 26 South, Range 29 East, Eddy County, New Mexico. Mewbourne seeks to dedicate the unit to the following wells:

1. **Fuller 13/12 Fed Com #571H** and **Fuller 13/12 Fed Com #522H** wells, to be drilled from surface hole locations in the NE/4 SW/4 (Unit K) of Section 13 to bottom hole locations in the NW/4 NW/4 (Unit D) of Section 12; and
2. **Fuller 13/12 Fed Com #523H**, **Fuller 13/12 Fed Com #574H**, and **Fuller 13/12 Fed Com #563H** wells, to be drilled from surface hole locations in the NE/4 SW/4 (Unit K) of Section 13 to bottom hole locations in the NE/4 NW/4 (Unit C) of Section 12.

In **Case No. 24796**, Mewbourne applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 480-acre, more or less, non-standard horizontal spacing unit comprised of the E/2 of Section 11 and the NE/4 of Section 14, Township 26 South, Range 29 East, Eddy County, New Mexico. Mewbourne seeks to dedicate the unit to the following wells:

1. **Fuller 14/11 Fed Com #568H**, **Fuller 14/11 Fed Com #527H**, and **Fuller 14/11 Fed Com #576H** wells, to be drilled from surface hole locations in the SE/4 NE/4 (Unit H) of Section 14 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 11; and
2. **Fuller 14/11 Fed Com #526H** and **Fuller 14/11 Fed Com #565H** wells, to be drilled from surface hole locations in the SE/4 NE/4 (Unit H) of Section 14 to bottom hole locations in the NW/4 NE/4 (Unit B) of Section 11.

Mewbourne also seeks approval of non-standard horizontal spacing units Approval of non-standard spacing units will allow Mewbourne to consolidate surface facilities and will consequently prevent surface, environmental, and economic waste, in addition to reducing emissions.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of

Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
