Case No. 24807: Application of Flat Creek Resources, LLC for Compulsory Pooling, Eddy County, New Mexico. Applicant in this case seeks an order from the Division pooling all uncommitted mineral interests in the Bone Spring formation in a standard 280-acre, more or less, horizontal spacing and proration unit ("HSU"), comprised of the N/2 NW/4 of Section 13 and N/2 N/2 of Section 14, Township 19 South, Range 27 East, in Eddy County, New Mexico. Applicant proposes to drill the following well in the HSU: Cardigan State Com 131H well, to be horizontally drilled from a surface hole location approximately 530' FNL and 1,420' FWL of Section 13, T19S-R27E to a bottomhole location approximately 455' FNL and 100' FWL of Section 14, T19S-R27E. The completed interval and first and last take points will meet statewide setback requirements for horizontal oil wells. Also to be considered will be the cost of drilling and completing the well and the allocation of the costs, the designation of Applicant as Operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
