**STATEMENT OF THE CASES**

In **Case No. 24818**, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico. The unit will be dedicated to the **Ironhorse 35-36 Fed State Com 200H** well, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 34 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 36.

In **Case No. 24819**, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico. The unit will be dedicated to the **Ironhorse 35-36 Fed State Com 201H** well, which will be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 34 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 36.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
