STATEMENT OF THE CASE

Mewbourne applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 960-acre, more or less, non-standard horizonal spacing unit comprised of Section 32 and the W/2 of Section 33, Township 20 South, Range 28 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the following wells ("Wells"):

- a) The **Overlord 33/32 Fed Com #711H (W0CD)** well, which will be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 33 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 32;
- b) The **Overlord 33/32 Fed Com #713H (W0FE)** well, which will be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 33 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 32;
- c) The **Overlord 33/32 Fed Com #715H (W0KL)** well, which will be drilled from a surface hole location in the NW/4 SE/4 (Unit J) of Section 33 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 32; and
- d) The **Overlord 33/32 Fed Com #718H (W0NM)** well, which will be drilled from a surface hole location in the NW/4 SE/4 (Unit J) of Section 33 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 32.

Applicant also requests that the Division vacate Order Nos. R-22574 (extended by Order R-22574-A), R-22575 (extended by Order R-22575-A), R-22576 (extended by Order R-22576-A), and R-22577 (extended by Order R-22577-A) (collectively "Orders"), which cover the subject acreage, due to a change in drilling plans. Applicant was designated operator of the units and the wells under these Orders.

Applicant has submitted an administrative application for approval of a non-standard horizontal spacing unit to the Division and is therefore not seeking approval of a non-standard spacing unit in this application.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of

Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Wells are located approximately 8.5 miles north-northeast of Carlsbad, New Mexico.
