STATEMENT OF THE CASE

In **Case No. 24827**, Applicant requests that the Division pool additional uncommitted interests under the terms of Order No. R-23006 (“Order”). On January 10, 2024, the Division entered the Order in Case No. 22172, which pooled all uncommitted interests in the Wolfcamp formation underlying a 634-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 19 and 20, Township 22 South, Range 27 East, Eddy County, New Mexico

(“Unit”); dedicated the Unit to **The Dude 19/20 Fee 203H and The Dude 19/20 Fee 204H** wells (“Wells”); and designated Applicant as operator of the Unit and Wells

Since Order No. R-23006 was entered, Applicant has identified additional uncommitted interests in the Unit that have not been pooled under the terms of the Order. Applicant requests that these additional interests be pooled into the Unit pursuant to the terms of the Order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands.
