**APPLICANT’S STATEMENT OF THE CASE(S)**

In **Case No. 24840**, Applicant seeks an order from the Division pooling all uncommitted interests in the Bone Spring formation (Forehand Ranch Bone Spring [24660]) underlying a standard 160-acre, more or less, horizontal spacing unit comprised of the E/2W/2 of Section 10, Township 24 South, Range 27 East, Eddy County, New Mexico. The proposed horizontal spacing unit will be dedicated to the Silver Bullet 10 State Com #132H to be horizontally drilled with first take point in the SE/4SW/4 (Unit N) of Section 10 and last take point in the NE/4NW/4 (Unit C) of Section 10. The producing area for the well is expected to be orthodox. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs and the actual operating costs and charges for supervision, designation of Civitas as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 6 miles west of Malaga, New Mexico.

In **Case No. 24841**, Applicant seeks an order from the Division pooling all uncommitted interests in the Bone Spring formation (Forehand Ranch Bone Spring [24660]) underlying a standard 160-acre, more or less, horizontal spacing unit comprised of the W/2W/2 of Section 10, Township 24 South, Range 27 East, Eddy County, New Mexico. The proposed horizontal spacing unit will be dedicated to the Silver Bullet 10 State Com #131H to be horizontally drilled with the first take point in the SW/4SW/4 (Unit M) of Section 10 and last take point in the NW/4NW/4 (Unit D) of Section 10. The producing area for the well is expected to be orthodox. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs and the actual operating costs and charges for supervision, designation of Civitas as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 6 miles west of Malaga, New Mexico.
