# **STATEMENT OF THE CASES**

Case Nos. 24721 and 24736 involve applications for the creation of a special pool, the Wolfbone Pool, that Cimarex and Pride Energy Company ("Pride") submitted respectively in response to Order No. R-23132. Following a Status Conference on August 22, 2024, Cimarex and Pride (collectively "Applicants") submitted a Joint Amended Application for a Special Pool ("Joint Amended Application") to be considered in lieu of proceeding to a contested hearing.

In the Joint Amended Application, the Applicants seek an order creating a special Wolfbone Pool, the Scharb; Wolfbone Pool underlying the W/2W/2 of Sections 12 and 13, all in Township 19 South, Range 34 East, NMPM, Lea County, New Mexico. Applicants propose that the vertical extent of the Scharb; Wolfbone Pool be from the stratigraphic equivalent of the top of the Third Bone Spring Sand to the stratigraphic equivalent of the base of Wolfcamp A Shale, as found in the compensated neutron density log of the Super Cobra State Com Well No. 1H (API No. 30-025-41987).
