**PERMIAN RESOURCES OPERATING, LLC'S  
UNOPPOSED MOTION TO DISMISS**

Permian Resources Operating, LLC (“Permian Resources”), by and through undersigned counsel, respectfully requests that the Oil Conservation Division (“Division”) enter an order dismissing Case Nos. 24161 and 24162. In support of this motion, Permian Resources states the following.

1. Permian Resources filed its applications on January 24, 2024, seeking to pool uncommitted interests in the Wolfcamp formation underlying a 1,920-acre, more or less, standard horizontal spacing unit comprised of Sections 23, 26 and 35, Township 20 South, Range 32 East, Lea County, New Mexico.

2. Permian Resources determined that revisions to its applications were necessary and filed replacement applications on October 4, 2024. The replacement applications have been assigned Case Nos. 24917 and 24918.

3. Permian Resources therefore requests that the Division dismiss Case Nos 24161 and 24162.

4. No party opposes this motion.

For the foregoing reasons, Permian Resources requests that the Division enter an Order dismissing Case Nos. 24161 and 24162.
