UNOPPOSED MOTION TO CONSOLIDATE

Avant Operating, LLC ("Avant") respectfully submits this Motion to Consolidate, requesting that the above captioned cases be consolidated, and that the status conference currently set for November 12, 2024 address both cases. As grounds for this motion, Avant states as follows:

- 1. The above captioned cases involve de novo applications filed by PBEX, LLC and E.G.L. Resources ("PBEX") seeking de novo review of two orders issued to Avant by the Oil Conservation Division, Order R-23279 and Order R-23353.
- 2. The Division issued Order R-23279 on July 31, 2024, in Division Case No. 24118. Order R-23279 pooled all uncommitted interests in a 640-acre, more or less, Bone Spring spacing unit, comprised of Section 13, Township 20 South, Range 33 East, Lea County, New Mexico, which unit will be dedicated to Avant's "Margie" Bone Spring wells.
- 3. PBEX filed its de novo application on August 28, 2024, and it was assigned Case No. 24816.
- 4. The Division issued Order R-23353 on September 11, 2024, in Division Case No. 24119. Order R-23353 pooled all uncommitted interests in a 640-acre, more or less, Wolfcamp spacing unit, comprised of Section 13, Township 20 South, Range 33

East, Lea County, New Mexico, which unit will be dedicated to Avant's "Margie" Wolfcamp wells.

- 5. PBEX filed its de novo application seeking review of Order R-23353 on September 17, 2024 and it was assigned OCC Case No. 24878.
- 6. Because Order R-23279 and R-23353are companion orders stemming from companion cases (OCD Case Nos. 24118 and 24119), Avant requests that the OCC cases be consolidated.
- 7. At the October 9, 2024 status conference on OCC Case No. 24878, the OCC set a status conference for November 12, 2024.
 - 8. Avant requests that both consolidated cases be set for that status conference.
- 9. Avant contacted counsel for PBEX who does not oppose this motion and counsel for COG Operating LLC and Concho Oil and Gas LLC who does not oppose this motion.

For the reasons stated herein, Avant respectfully requests that Case Nos. 24816 and 24878 be consolidated and that the status conference currently set for November 12, 2024 address both cases.
