APPLICATION

V-F Petroleum Inc. (“V-F” or “Applicant”), OGRID No. 24010, through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, Section 70-2-17, seeking to reopen Case No. 23781 and amend Order No. R-22947 to allow a one-year extension of the well drilling commencement deadline. Order No. R-22947 pooled uncommitted owners in the Bone Spring formation (Travis; Bone Spring Pool [Pool Code 97257]), an oil pool, underlying a non-standard 640-acre, more or less, spacing unit comprised of the S/2 of Section 32 and the S/2 of Section 33, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico. Paragraph 21 of the Order allows for an extension by amendment for good cause shown. In support of its application to extend the commencement date of the wells in the unit, V-F states the following:

V-F is in good standing under state-wide rules and regulations with respect to Order No. R-22947. However, as the one-year deadline was approaching, V-F has experienced unanticipated obstacles and delays in securing a rig for the commencement of drilling. A one-year extension of the well commencement date would allow V-F to secure a rig and pursue development of the unit without interruption.

WHEREFORE, V-F respectfully requests that this Application be set for hearing before an Examiner of the Oil Conservation Division on October 31, 2024, and after notice and hearing as required by law, that the Division amend Order No. R-22947 in a manner that provides for a one-year extension of the well commencement deadline.

Under the original Order, V-F would be required to commence drilling of the wells (Buchanan 33-32 State Com 231H and the Buchanan 33-32 State Com 232H) by October 31, 2024; and therefore, asks that the deadline for the commencement drilling date be extended a year, to October 31, 2025, thereby, affording V-F the opportunity to continue its development of the unit without interruption.

Application of V-F Petroleum Inc. to Amend Order No. R-22947 for an Extension of the Commencement Date, Eddy County, New Mexico. Applicant in the above-styled cause seeks to re-open Case No. 23781 and amend Division Order No. R-22947 in order to obtain, based on good cause shown, a one-year extension of the well commencement deadline, such that the drilling deadline would be extended to October 31, 2025. Order No. R-22947 pooled uncommitted interest owners and granted Applicant operating rights for wells (Buchanan 33-32 State Com 231H and the Buchanan 33-32 State Com 232H) to be drilled in a non-standard 320-acre, more or less, spacing unit comprised of the S/2 of Section 32 and the S/2 of Section 33, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico. The wells and lands are located approximately 18.5 miles southeast, of Artesia, New Mexico.

ORDER

The Director of the New Mexico Oil Conservation Division (“OCD”), having heard this matter through a Hearing Examiner on October 5, 2023, and after considering the testimony, evidence, and recommendation of the Hearing Examiner, issues the following Order.

FINDINGS OF FACT

1. V-F Petroleum Inc. (“Operator”) submitted an application (“Application”) to compulsory pool the uncommitted oil and gas interests within the spacing unit (“Unit”) described in Exhibit A. Operator seeks to be designated the operator of the Unit.
2. Operator will dedicate the well(s) described in Exhibit A (“Well(s)”) to the Unit.
3. Operator proposes the supervision and risk charges for the Well(s) described in Exhibit A.
4. Operator identified the owners of uncommitted interests in oil and gas minerals in the Unit and provided evidence that notice was given.
5. The Application was heard by the Hearing Examiner on the date specified above, during which Operator presented evidence through affidavits in support of the Application. No other party presented evidence at the hearing.

CONCLUSIONS OF LAW

6. OCD has jurisdiction to issue this Order pursuant to NMSA 1978, Section 70-2-17.
7. Operator is the owner of an oil and gas working interest within the Unit.
8. Operator satisfied the notice requirements for the Application and the hearing as required by 19.15.4.12 NMAC.
9. OCD satisfied the notice requirements for the hearing as required by 19.15.4.9 NMAC.
10. Operator has the right to drill the Well(s) to a common source of supply at the depth(s) and location(s) in the Unit described in Exhibit A.

11. The Unit contains separately owned uncommitted interests in oil and gas minerals.
12. Some of the owners of the uncommitted interests have not agreed to commit their interests to the Unit.
13. The pooling of uncommitted interests in the Unit will prevent waste and protect correlative rights, including the drilling of unnecessary wells.
14. This Order affords to the owner of an uncommitted interest the opportunity to produce his just and equitable share of the oil or gas in the pool.

ORDER

15. The uncommitted interests in the Unit are pooled as set forth in Exhibit A.
16. The Unit shall be dedicated to the Well(s) set forth in Exhibit A.
17. Operator is designated as operator of the Unit and the Well(s).
18. If the location of a well will be unorthodox under the spacing rules in effect at the time of completion, Operator shall obtain the OCD's approval for a non-standard location in accordance with 19.15.16.15(C) NMAC.
19. If the Unit is a non-standard horizontal spacing unit which has not been approved under this Order, Operator shall obtain the OCD's approval for a non-standard horizontal spacing unit in accordance with 19.15.16.15(B)(5) NMAC.
20. The Operator shall commence drilling the Well(s) within one year after the date of this Order, and complete each Well no later than one (1) year after the commencement of drilling the Well.
21. This Order shall terminate automatically if Operator fails to comply with Paragraph 20 unless Operator obtains an extension by amending this Order for good cause shown.
22. The infill well requirements in 19.15.13.9 NMAC through 19.15.13.12 NMAC shall be applicable.
23. Operator shall submit each owner of an uncommitted working interest in the pool ("Pooled Working Interest") an itemized schedule of estimated costs to drill, complete, and equip the well ("Estimated Well Costs").
24. No later than thirty (30) days after Operator submits the Estimated Well Costs, the owner of a Pooled Working Interest shall elect whether to pay its share of the Estimated Well Costs or its share of the actual costs to drill, complete and equip the well ("Actual Well Costs") out of production from the well. An owner of a Pooled

Working Interest who elects to pay its share of the Estimated Well Costs shall render payment to Operator no later than thirty (30) days after the expiration of the election period, and shall be liable for operating costs, but not risk charges, for the well. An owner of a Pooled Working Interest who fails to pay its share of the Estimated Well Costs or who elects to pay its share of the Actual Well Costs out of production from the well shall be considered to be a "Non-Consenting Pooled Working Interest."

25. No later than one hundred eighty (180) days after Operator submits a Form C-105 for a well, Operator shall submit to each owner of a Pooled Working Interest an itemized schedule of the Actual Well Costs. The Actual Well Costs shall be considered to be the Reasonable Well Costs unless an owner of a Pooled Working Interest files a written objection no later than forty-five (45) days after receipt of the schedule. If an owner of a Pooled Working Interest files a timely written objection, OCD shall determine the Reasonable Well Costs after public notice and hearing.
26. No later than sixty (60) days after the expiration of the period to file a written objection to the Actual Well Costs or OCD's order determining the Reasonable Well Costs, whichever is later, each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs shall pay to Operator its share of the Reasonable Well Costs that exceed the Estimated Well Costs, or Operator shall pay to each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs its share of the Estimated Well Costs that exceed the Reasonable Well Costs.
27. The reasonable charges for supervision to drill and produce a well ("Supervision Charges") shall not exceed the rates specified in Exhibit A, provided however that the rates shall be adjusted annually pursuant to the COPAS form entitled "Accounting Procedure-Joint Operations."
28. No later than within ninety (90) days after Operator submits a Form C-105 for a well, Operator shall submit to each owner of a Pooled Working Interest an itemized schedule of the reasonable charges for operating and maintaining the well ("Operating Charges"), provided however that Operating Charges shall not include the Reasonable Well Costs or Supervision Charges. The Operating Charges shall be considered final unless an owner of a Pooled Working Interest files a written objection no later than forty-five (45) days after receipt of the schedule. If an owner of a Pooled Working Interest files a timely written objection, OCD shall determine the Operating Charges after public notice and hearing.
29. Operator may withhold the following costs and charges from the share of production due to each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs: (a) the proportionate share of the Supervision Charges; and (b) the proportionate share of the Operating Charges.

- 30. Operator may withhold the following costs and charges from the share of production due to each owner of a Non-Consenting Pooled Working Interest: (a) the proportionate share of the Reasonable Well Costs; (b) the proportionate share of the Supervision and Operating Charges; and (c) the percentage of the Reasonable Well Costs specified as the charge for risk described in Exhibit A.
- 31. Operator shall distribute a proportionate share of the costs and charges withheld pursuant to paragraph 29 to each Pooled Working Interest that paid its share of the Estimated Well Costs.
- 32. Each year on the anniversary of this Order, and no later than ninety (90) days after each payout, Operator shall provide to each owner of a Non-Consenting Pooled Working Interest a schedule of the revenue attributable to a well and the Supervision and Operating Costs charged against that revenue.
- 33. Any cost or charge that is paid out of production shall be withheld only from the share due to an owner of a Pooled Working Interest. No cost or charge shall be withheld from the share due to an owner of a royalty interests. For the purpose of this Order, an unleased mineral interest shall consist of a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest.
- 34. Except as provided above, Operator shall hold the revenue attributable to a well that is not disbursed for any reason for the account of the person(s) entitled to the revenue as provided in the Oil and Gas Proceeds Payment Act, NMSA 1978, Sections 70-10-1 *et seq.*, and relinquish such revenue as provided in the Uniform Unclaimed Property Act, NMSA 1978, Sections 7-8A-1 *et seq.*
- 35. The Unit shall terminate if (a) the owners of all Pooled Working Interests reach a voluntary agreement; or (b) the well(s) drilled on the Unit are plugged and abandoned in accordance with the applicable rules. Operator shall inform OCD no later than thirty (30) days after such occurrence.
- 36. OCD retains jurisdiction of this matter for the entry of such orders as may be deemed necessary.

SELF-AFFIRMED STATEMENT OF JORDAN SHAW

I, Jordan Shaw, state and affirm the following:

1. I am over the age of eighteen years and have the capacity to execute this Affidavit, which is based on my personal knowledge.
2. I am a Landman with V-F Petroleum Inc. ("V-F"), and I am familiar with the subject application and the lands involved.
3. I graduated in 2009 from the Indiana University of Pennsylvania with a bachelor's degree in Political Science, Pre-Law and graduated in 2013 from Texas Tech University, School of Law with a Juris Doctor and am licensed to practice law in the State of Texas. I have worked at V-F Petroleum Inc. for approximately three years and have been working as a Landman/Attorney for three years. I have not previously testified before the Oil Conservation Division ("Division"), and request my credentials be accepted of record. I have provided the Division with a one page resume, attached hereto, for review of my qualifications.



4. This Self-affirmed Statement is submitted in connection with the filing by V-F of the above-referenced application to reopen Case No. 23781 and amend Order No. R-22947 in order to allow a one-year extension of the well commencement deadline. Order No. R-22947 pooled uncommitted owners in the Bone Spring formation, Travis; Bone Spring Pool (Pool Code 97257), an oil pool, underlying a non-standard 640-acre, more or less, spacing unit comprised of the S/2 of Sections 32 and 33, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico.

5. The Pooling Order allows for an extension for good cause, and in accordance with this requirement, V-F states the following: (1) V-F is in good standing under state-wide rules and regulations with respect to Order No. R-22947; (2) V-F has made progress toward the development of the unit since issuance of the Order by working to schedule a drilling rig, among other efforts; and (3) while facing the approaching one-year deadline, V-F has experienced unanticipated delays in securing a rig for the commencement of drilling. As a result, V-F respectfully requests that an extension of time for the drilling commencement date be granted to ensure that a rig can be secured without unnecessary rush to meet the impending deadline.

6. Under the original Order, V-F would be required to commence drilling by October 31, 2024; and therefore, V-F asks for the deadline to commence drilling be extended for a year, to October 31, 2025, thereby affording V-F the opportunity to continue its development of the unit without interruption.

7. V-F, through its counsel, timely notified all pooled parties of V-F's request to re-open the Case and amend the Order for the purpose of extending the well commencement deadline, as shown in Exhibit B and its sub-exhibits herein. Notice to seven (7) interest owners: Patricia Ann Glass, New Mexico Western Minerals, Inc., Bean Family Limited Company, Mary Ann Twitty, Katherine Ann Malone, Pamela Ann Evans (aka Patricia Ann Glass), and Read &

Stevens, Inc., are listed as To Be Returned. V-F has also timely published notice in the Carlsbad Current Argus, a newspaper of general circulation for Eddy County, New Mexico, to account for any contingencies regarding notice.

8. The granting of this Application is in the best interests of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.
