STATEMENT OF THE CASES

In **Case No. 24890**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Sections 26 and 35, Township 18 South, Range 33 East, Lea County, New Mexico. The unit will be dedicated to the **Mercury 26 35 Fed Com #123H** well, which will be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 26 to a bottom hole

location in the SW/4 SE/4 (Unit O) of Section 35. The completed interval of the well is expected to be unorthodox.

In **Case No. 24891**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Sections 26 and 35, Township 18 South, Range 33 East, Lea County, New Mexico. The Unit will be dedicated to the **Mercury 26 35 Fed Com #124H** well, which will be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 26 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 35. The completed interval of the well is expected to be orthodox.

Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
