**APPLICANT’S STATEMENT OF THE CASE**

In **Case No. 24921**, MRC seeks to amend pooling Order R-23188 to add additional mineral interest owners to the pooling order. On May 9, 2024, the Division entered Order R-23188 in Case No. 24217 and pooled uncommitted mineral interest owners in the Bone Spring formation (Malaga; Bone Spring, North Pool [42800]) underlying the N/2 S/2 of Sections 9 and 10, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. This standard 320-acre horizontal well spacing unit is currently dedicated to the **Prater 10&9 24S-28E RB #113H** and **Prater 10&9 24S-28E RB #123H** wells.

In **Case No. 24922**, Matador seeks an order to amend Order R-23189 to add additional mineral interest owners to the pooling order. On May 9, 2024, the Division entered Order R-23189 in Case No. 24218 and pooled the uncommitted interests in the Bone Spring formation (Malaga; Bone Spring, North Pool [42800]) underlying the S/2 S/2 of Sections 9 and 10, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. This standard 320-acre horizontal well spacing unit is currently dedicated to the **Prater 10&9 24S-28E RB #114H** and **Prater 10&9 24S-28E RB #124H** wells.

Applicant has discovered additional mineral interest owners in the pooled acreage that were not subject to the pooling proceedings giving rise to Order R-23188 and Order R-23189. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from these additional mineral interest owners and requests to add them under the existing orders.
