## APPLICATION OF PERMIAN RESOURCES OPERATING, LLC FOR COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO

## **APPLICATION**

Permian Resources Operating, LLC, OGRID No. 372165 ("Permian" or "Applicant") files

this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978,

§ 70-2-17 (2023), seeking an order pooling all mineral interests in the Wolfcamp formation in an

800 acre, more or less, horizontal spacing and proration unit ("HSU") comprised of the SW/4 of

Section 4 and S/2 of Sections 5 and 6, all in Township 22 South, Range 26 East, in Eddy County,

New Mexico. In support of its application, Permian states as follows:

1. Permian is a working interest owner in the proposed HSU and has the right to drill

thereon.

- 2. Permian proposes to drill the following 2.5-mile wells in the proposed HSU:
  - **Dreamcatcher 4 Fed Com 213H** well, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 1650 feet FSL and 100' FWL of Section 6, T22S-R26E; and
  - **Dreamcatcher 4 Fed Com 214H** well, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 330 feet FSL and 100' FWL of Section 6, T22S-R26E.
  - **Dreamcatcher 4 Fed Com 423H** well, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 2311 feet FSL and 100' FWL of Section 6, T22S-R26E.

• **Dreamcatcher 4 Fed Com 424H** well, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 990 feet FSL and 100' FWL of Section 6, T22S-R26E.

3. The completed intervals and first and last take points will be at non-standard locations. Applicant will submit applications for administration approval of the non-standard locations.

4. Permian has in good faith sought and been unable to obtain voluntary agreement for the development of these lands from all of the mineral interest owners in the HSU.

5. Approval of the HSU and the pooling of all mineral interest owners in the Wolfcamp formation underlying the HSU will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

6. In order to permit Permian to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in this HSU should be pooled and Permian should be designated the operator of the HSU.

WHEREFORE, Permian requests that this application be set for hearing before an Examiner of the Oil Conservation Division on the January 9, 2025 docket, and that, after notice and hearing as required by law, the Division enter an order:

A. Creating an 800-acre, more or less, HSU comprised of the SW/4 of Section 4 and S/2 of Sections 5 and 6, all in Township 22 South, Range 26 East, in Eddy County, New Mexico;

B. Pooling all mineral interests in the Wolfcamp formation underlying the HSU;

C. Allowing the drilling of the following 2.5-mile wells in the HSU: Dreamcatcher 4

Fed Com 213H, Dreamcatcher 4 Fed Com 214H, Dreamcatcher 4 Fed Com 423H, and Dreamcatcher 4 Fed Com 424H wells;

D. Designating Permian as operator of the HSU and the wells to be drilled thereon;

E. Authorizing Permian to recover its costs of drilling, equipping, and completing the wells;

F. Approving the operating charges and costs of supervision while drilling of \$10,000/month and, after completion, \$1,000/month, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

G. Imposing a 200% penalty for the risk assumed by Permian in drilling and completing the wells against any interest owner who does not voluntarily participate in the drilling of the wells.

Application of Permian Resources Operating, LLC for Compulsory Pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order from the Oil Conservation Division pooling all uncommitted mineral interests in the Bone Spring formation in an 800-acre, more or less, horizontal spacing and proration unit ("HSU") comprised of the SW/4 of Section 4 and S/2 of Sections 5 and 6, T22S-R26E, in Eddy County, New Mexico. Applicant proposes to drill the following 2.5-mile wells in the HSU: (1) Dreamcatcher 4 Fed Com 213H, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 1650 feet FSL and 100' FWL of Section 6, T22S-R26E; (2) Dreamcatcher 4 Fed Com 214H, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 330 feet FSL and 100' FWL of Section 6, T22S-R26E; (3) Dreamcatcher 4 Fed Com 423H, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 2311 feet FSL and 100' FWL of Section 6, T22S-R26E; and (4) Dreamcatcher 4 Fed Com 424H, to be horizontally drilled from an approximate surface hole location within the SW/4 of Section 4, T22S-R26E, to an approximate bottom hole location 990 feet FSL and 100' FWL of Section 6, T22S-R26E. The completed intervals and first and last take points will not meet standard setback requirements. Applicant will be seeking administrative approval of non-standard locations. Additional considerations will be the cost of drilling and completing the wells and allocation of such costs, the designation of Applicant as operator of the HSU and wells to be drilled thereon, and a 200% charge for the risk involved in drilling and completing the wells. The wells and lands are located approximately 1 mile West of Carlsbad, New Mexico.
