# **STATEMENT OF THE CASE**

BTA seeks an order pooling all uncommitted interests in the Pennsylvanian Shale formation underlying a 319.42-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 33, Township 16 South, Range 36 East, and Lot 3, SE/4 NW/4, and E/2 SW/4 (E/2 W/2 equivalent) of irregular Section 4, Township 17 South, Range 36 East, Lea County, New Mexico ("Unit"). The Unit will be dedicated to the **Capitan 22301 33-4 State Com #23H** well ("Well"), which will produce from a first take point in the NE/4 NW/4 (Unit C) of Section

33, Township 16 South, to a last take point in the SE/4 SW/4 (Unit N) of Section 4, Township 17 South.

The completed interval of the Well will be orthodox. Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

The Well is located approximately 2 miles south of Lovington, New Mexico.
