#### STATEMENT OF THE CASES

In **Case No. 25022**, Applicant seeks an order pooling additional interests under the terms of Order No. R-22846. The Division entered Order No. R-22846 in Case No. 23589 on August 25, 2023. The order pooled uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, non-standard horizontal spacing unit comprised of the W/2 of Sections 7 and 18, Township 23 South, Range 26 East, Eddy County, New Mexico<sup>1</sup>, dedicated the unit to the **Rena 7 Fed Com 702H** well, and designated Applicant as operator of the unit and well. On September 19, 2024, the Division issued Order No. R-22846-A, extending the deadline to commence drilling the well until August 25, 2025. Since Order No. R-22846-A was entered, Applicant has identified additional uncommitted interests in the unit that have not been pooled. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, the additional interests should be pooled into the unit pursuant to the terms of Order No. R-22846.
