STATEMENT OF THE CASES

In Case No. 25073, Permian Resources applies for an order pooling all uncommitted interests from the top of the Bone Spring formation to the base of the Second Bone Spring interval underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 14 and 13, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the Wombat 13 Fed Com 121H well, which will produce from a first take point in the NE/4 NE/4 (Unit A) of Section 13 to a last take point in the NW/4 NW/4 (Unit D) of Section

14. The completed interval of the well is expected to be orthodox. Due to a depth severance within the unit, Applicant seeks to pool uncommitted interests from the top of the Bone Spring formation to the base of the Second Bone Spring interval at a stratigraphic equivalent of approximately 7,988' MD as shown on the Yates-Federal #2 well log (API #30-015-20970).

In Case No. 25074, Permian Resources applies for an order pooling all uncommitted interests from the top of the Bone Spring formation to the base of the Second Bone Spring interval underlying a 480-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 14 and the N/2 S/2 of Sections 13 and 14, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the Wombat 13 Fed Com 123H "j-turn" well ("Well"), which will produce from a first take point in the NE/4 SE/4 (Unit I) of Section 13 to a last take point in the SE/4 NE/4 (Unit H) of Section 14. The completed interval of the well is expected to be orthodox. Due to a depth severance within the unit, Applicant seeks to pool uncommitted interests from the top of the Bone Spring formation to the base of the Second Bone Spring interval at a stratigraphic equivalent of approximately 7,988 MD' as show on the Yates-Federal #2 (API #30-015-20970).

In Case No. 25075, Permian Resources applies for an order pooling all uncommitted interests from the top of the Bone Spring formation to the base of the Second Bone Spring interval underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 14 and 13, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Wombat 13 Fed Com 124H** well, which will produce from a first take point in the SE/4 SE/4 (Unit P) of Section 13 to a last take point in the SW/4 SW/4 (Unit M) of Section 14. The completed interval of the well is expected to be orthodox. Due to a depth severance within the unit, Applicant seeks to pool uncommitted interests from the top of the Bone Spring formation

to the base of the Second Bone Spring interval at a stratigraphic equivalent of approximately 7,988' MD as shown on the Yates-Federal #2 well log (API #30-015-20970).

Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The wells are located approximately 10 miles northeast of Carlsbad, New Mexico.
