#### **APPLICATION**

FE Permian Owner I, LLC, ("Applicant"), in conjunction with its designated operator Flat Creek Resources, LLC, ("Flat Creek Resources") OGRID No. 374034 (collectively "Flat Creek"), through its undersigned attorneys, hereby files this Application with the Oil Conservation Division ("Division") pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a non-standard 960-acre, more or less, spacing and proration unit comprised of the S/2 NW/4 and SW/4 of Section 13, the S/2 N/2 and S/2 of Section 14, and the S/2 NE/4 and SE/4 of Section 15, all in Township 19 South, Range 27 East, NMPM, Eddy County, New Mexico. In support of its Application, Flat Creek states the following:

1. Applicant is a working interest owner in the proposed horizontal spacing and proration unit ("HSU") and has the right to drill a well thereon. Applicant designates Flat Creek Resources, as the operator of the HSU and wells.

2. Applicant proposes and dedicates to the HSU the **Cardigan Fed Com 132H Well**, the **Cardigan Fed Com 133H Well**, and the **Cardigan Fed Com 134H Well**, as initial wells, to be drilled to a sufficient depth to test the Bone Spring formation.

3. Applicant proposes the **Cardigan Fed Com 132H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 SW/4 (Unit K) of Section 13 to a bottom hole location in the SW/4 NE/4 (Unit G) of Section 15.

4. Applicant proposes the **Cardigan Fed Com 133H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 SW/4 (Unit K) of Section 13 to a bottom hole location in the NW/4 SE/4 (Unit J) of Section 15.

5. Applicant proposes the **Cardigan Fed Com 134H Well,** an oil well, to be horizontally drilled from a surface location in the NE/4 SW/4 (Unit K) of Section 13 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 15.

6. All the wells proposed herein are orthodox in their location, as the take points and completed intervals will comply with setback requirements for standard locations under the statewide rules.

7. This is a non-standard spacing (NSP) unit, and Applicant is applying for administrative approval of the NSP unit.

8. Applicant has sought in good faith, but has been unable to obtain, voluntary agreement from all interest owners to participate in the drilling of the well or in the commitment of their interests to the well for their development within the proposed HSU.

9. The pooling of all interests in the Bone Spring formation within the proposed HSU will avoid the drilling of unnecessary wells, prevent waste and protect correlative rights.

10. In order to provide for its just and fair share of the oil and gas underlying the subject lands, Applicant requests that all uncommitted interests in this HSU be pooled and that Flat Creek Resources be designated the operator of the proposed horizontal wells and HSU.

WHEREFORE, Applicant requests that this Application be set for hearing on January 9, 2025, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

A. Pooling all uncommitted mineral interests in the Bone formation underlying a nonstandard 960-acre, more or less, spacing and proration unit comprised of the S/2 NW/4 and SW/4 of Section 13, the S/2 N/2 and S/2 of Section 14, and the S/2 NE/4 and SE/4 of Section 15, all in Township 19 South, Range 27 East, NMPM, Eddy County, New Mexico.

B. Approving the Cardigan Fed Com 132H Well, the Cardigan Fed Com 133HWell, and the Cardigan Fed Com 134H Well, as the wells for the HSU.

C. Designating Flat Creek Resources as the designated operator of this HSU and the horizontal wells to be drilled thereon;

D. Authorizing Flat Creek to recover its costs of drilling, equipping, and completing the wells;

E. Approving actual operating charges and costs of supervision, to the maximum extent allowable, while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

F. Setting a 200% charge for the risk assumed by Applicant in drilling and completing the wells in the event a working interest owner elects not to participate in the well.

#### SELF-AFFIRMED STATEMENT OF MIKE GREGORY

I, being duly sworn on oath, state the following:

1. I am over the age of eighteen years and have the capacity to execute this Affidavit, which is based on my personal knowledge.

2. I am employed as Vice President of Land with Flat Creek Resources, LLC ("Flat Creek"), and I am familiar with the subject application and the lands involved.

3. I graduated in 2008 from Texas Tech University with a bachelor's degree in Energy Commerce. I have worked at Flat Creek for approximately 6 years, and I have been working in New Mexico for 8 years. I have previously testified before the New Mexico Oil Conservation Division ("Division") as an expert witness in petroleum land matters and my credentials have been accepted by the Division and made a matter of record.

4. This affidavit is submitted in connection with the filing by Flat Creek of the abovereferenced spacing and compulsory pooling applications pursuant to 19.15.4.12.A(1). Flat Creek seeks an order pooling all uncommitted mineral interest in the Bone Spring underlying a nonstandard 960-acre, more or less, spacing and proration unit comprised of the S/2 NW/4 and SW/4 of Section 13, the S/2 N/2 and S/2 of Section 14, and the S/2 NE/4 and SE/4 of Section 15, all in Township 19 South, Range 27 East, NMPM, Eddy County, New Mexico.



5. Under <u>Case No. 25053</u>, Flat Creek seeks to dedicate to the unit the **Cardigan Fed Com 132H Well,** the **Cardigan Fed Com 133H Well,** and the **Cardigan Fed Com 134H Well**, as the initial wells, to be drilled to a sufficient depth to test the Bone Spring formation.

6. The **Cardigan Fed Com 132H Well**, an oil well, will be horizontally drilled from a surface location in the NE/4 SW/4 (Unit K) of Section 13 to a bottom hole location in the SW/4 NE/4 (Unit G) of Section 15; approximate TVD of 7,718'; approximate TMD of 19,215; FTP in Section 13: 1,652' FNL, 2,567' FWL; LTP in Section 15: 1,730' FNL, 2,547' FEL.

7. The **Cardigan Fed Com 133H Well**, an oil well, will be horizontally drilled from a surface location in the NE/4 SW/4 (Unit K) of Section 13 to a bottom hole location in the NW/4 SE/4 (Unit J) of Section 15; approximate TVD of 7,755'; approximate TMD of 18,990'; FTP in Section 13: 1,978' FSL, 2,548' FWL; LTP in Section 15: 1,883' FSL, 2,545' FEL

8. The **Cardigan Fed Com 134H Well**, an oil well, will be horizontally drilled from a surface location in the NE/4 SW/4 (Unit K) of Section 13 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 15; approximate TVD of 7,797'; approximate TMD of 19,234'; FTP in Section 13: 478' FSL, 2,531' FWL; LTP in Section 15: 383' FSL, 2,543' FEL

9. The proposed C-102 for each well is attached as **Exhibit A-1**. The location of each well is orthodox, and it meets the Division's offset requirements.

10. A general location plat and a plat outlining the units being pooled is attached hereto as **Exhibit A-2**.

11. The parties being pooled, the nature of their interests, and their last known addresses are listed on **Exhibit A-3** attached hereto. **Exhibit A-3** includes information regarding working interest owners and overriding royalty interest owners.

12. There are no depth severances in the Bone Spring formation in this acreage.

13. I provided the law firm of Abadie & Schill P.C. a list of names and addresses for the uncommitted interest owners shown on **Exhibit A-3**. In compiling these addresses, I conducted a diligent search of the public records in Eddy County, New Mexico, where the wells are located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. All working interest received notice by sending notice letters to their last known address and timely publishing notice. Notice to one small working interest owner, J. Cleo Thompson and James Cleo Thompson, Jr., LP, is still listed as in transit. Notice to one State Land Office Lessee of Record, Tap Rock Resources III, LLC, is listed as In Transit. Notice to eight (8) of the ORRI owners are still listed as in-transit,: Loco Hills Production Company, LLC, Lowe Royalty Partners, LP, C. Mark Wheeler, Jareed Partners, Ltd., Errett Allan Hummel, Trustee of the Errett Allan Hummel Living Trust, Virginia Michelle Hummel Arrington, Trustee of the Virginia Michelle Hummel Living Trust, L. S. Henry, LLC, and Mountain Lion Oil and Gas, LLC. Notice to six (6) overriding interest owners are listed as To Be Returned: Ergodic Resources, LLC, Mark Wilson Family Partnership, L.P., Rio Pecos Corporation, Hollyhock Corp, Yates Brothers (Harvey E. Martin, S.P., and John A. Yates), and Lewis A. Woodall Living Trust. Flat Creek published notice in the Carlsbad Current-Argus, a newspaper of general circulation in Eddy County, New Mexico, to account for any unlocatable parties and cover any contingencies regarding notice.

14. Flat Creek has made a good faith effort to negotiate with the interest owners, but has been unable to obtain, voluntary agreement from all interest owners to participate in the drilling of the well or in the commitment of their interests to the well for its development within the proposed horizontal spacing unit. **Exhibit A-5** provides a chronology and history of contacts with the owners.

15. The interest owners being pooled have been contacted regarding the proposed wells but have failed or refused to voluntarily commit their interest in the wells. However, Flat Creek has been in ongoing discussions with some of the interest owners to voluntarily enter into a Joint Operating Agreement. If a mutually agreeable Joint Operating Agreement is reached between Flat Creek and any of the interest owners, Flat Creek requests that the voluntary agreement become operative and supersede the Division's order for said parties.

16. **Exhibit A-4** is a sample proposal letter and the AFEs for each proposed well. The estimated cost of the wells set forth in the AFEs is fair, reasonable, and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.

17. The spacing unit proposed herein is non-standard spacing ("NSP") unit, and the Applicant will be applying for administrative approval of the NSP unit.

18. Flat Creek requests overhead and administrative rates of \$8,000/month for drilling each well and \$800/month for producing each well. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of southeastern New Mexico. Flat Creek requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

19. Flat Creek requests the maximum cost, plus 200% risk charge be assessed against non-consenting working interest owners.

20. Flat Creek requests that it be designated operator of the units and wells.

21. The Exhibits to this Affidavit were prepared by me or compiled from Flat Creek's company business records under my direct supervision.

22. The granting of this Application is in the best interests of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

#### AFFIRMATION OF GEOLOGIST THOMAS M. ANDERSON

I, Thomas M. Anderson, make the following self-affirmed statement:

1. I am over the age of 18, and have the capacity to execute this affirmation, which is based on my personal knowledge.

2. I am employed as the geologist for Flat Creek Resources, LLC ("Flat Creek" or "Applicant"), and I am familiar with the subject applications and the lands involved.

3. This affirmation is submitted in connection with the filing by Flat Creek of the above-referenced compulsory pooling applications pursuant to 19.15.4.12.A(1) NMAC.

4. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My credentials as a petroleum geologist have been accepted by the Division and made a matter of record. My education and work experience are as follows: I have a bachelor's degree in geology from the University of South Florida and a master's degree in geology from Florida State University. I have been working continuously as a professional geologist since 1981. I worked at Exxon/ExxonMobil/XTO Energy for 37 years and have been at Flat Creek Resources, LLC for 6 years. Since 2011 I have worked fulltime in the Permian Basin, including the northern portion of the Delaware and the NW Shelf in New Mexico.

5. **Exhibit B-1** is a location map of the Delaware Basin highlighting the position of the project area.



6. **Exhibit B-2** is a TVDSS structure map on the base of 3rd Bone Spring sand (top Wolfcamp) and a reference map for the cross section. Contour interval is 50'. The top defines the base of the target interval for the proposed wells. The proposed spacing unit is outlined by the black rectangle and the proposed horizontal wells are shown in blue. There is no evidence of faults, pinch-outs or other significant impediments to the horizontal development in either of the objectives.

7. **Exhibit B-3** is a stratigraphic cross-section flattened on the base of the 3<sup>rd</sup> Bone Spring sand (top Wolfcamp). Log curves for each well on the section consist of a gamma ray/caliper, deep resistivity, and neutron/density porosity. The targeted interval for the proposed wells is shaded yellow.

8. **Exhibit B-4** is a gun barrel diagram of the Cardigan development plan. The horizontal well spacing is to scale.

9. **Exhibit B-5 is** a gross isochore of the 3<sup>rd</sup> Bone Spring sand.

10. The measured depths and true vertical depths for each well in Case No. 25053 are approximately as follows:

11. Based on my geologic study of the area, I conclude the following:

a. The horizontal spacing and proration units ("HSU") are justified from a geologic standpoint.

- b. There are no structural impediments or faults that will interfere with horizontal development.
- c. Each quarter-quarter section in the Bone Spring HSUs will contribute more or less equally to production.

12. The planned well orientation in this area is east-west to complement existing development in the immediate area. The measured orientation of the maximum horizontal stress averages N1.4°E (based on 5 high quality measurements approximately 10 miles east of the project area from data tables from Lundstern, JE., Zoback, M.D. Author Correction: Multiscale variations of the crustal stress field throughout North America. *Nat Commun* **14**, 1232 (2023). https://doi.org/10.1038/s41467-022-34915-0). These measurements strongly favor an east-west orientation.

13. The subject acreage represents a sizeable percentage of Flat Creek's total acreage and will have the complete attention of the company with the goal of optimizing and accelerating operations.

15. The granting of the Applications is in the interests of conservation, the prevention of waste, and the protection of correlative rights.






General Location Map


 Location of the Cardigan project is shown inside the red circle in the northwest corner of the basin behind the Capitan Reef in Eddy County









