**AMENDED ENTRY OF APPEARANCE &  
OBJECTION TO HEARING BY AFFIDAVIT**

Cimarex Energy Co., subsidiary of Coterra Energy, Inc. (“Cimarex”), filed an Entry of Appearance and Objection to Hearing By Affidavit (“EOA and OBJ”) on January 6, 2025, in Case Nos. 25034, 25035, 25036, 25037, and 25038. In response to Cimarex’s EOA and OBJ, MRC Permian Company (“MRC”) moved to strike the EOA and OBJ for Case Nos. 25034 and 25036 (“Motion”), pointing out that these two cases seek to pool the Bone Spring and Wolfcamp underlying the W/2 of Sections 3 and 10, Township 21 South, Range 32 East, Lea County, New Mexico, and that the EOA and OBJ should be stricken for Case Nos. 25034 and 25036 because Cimarex does not own in the W/2 of Sections 3 and 10.

After receipt of the MRC’s Motion, Cimarex reviewed its records and confirmed that MRC is correct in its assessment of ownership for the W/2 of Sections 3 and 10. Cimarex’s ownership is within the E/2 of Sections 3 and 10. Consequently, Cimarex is filing this Amended Entry of Appearance & Objection to Hearing by Affidavit in order to withdraw its Entry of Appearance and

Objection in Case Nos. 25034 and 25036. Cimarex maintains its entry of appearance and objections to hearings by affidavit in Case Nos. 25035, 25037, and 25038, the cases which cover the E/2 of Sections 3 and 10.

Therefore, Cimarex objects to Case Nos. 25035, 25037, and 25038 going forward by affidavit and withdraws its entry of appearance and objections to Case Nos. 25034 and 24036.
