AMENDED APPLICATION OF ALPHA ENERGY PARTNERS, LLC, TO POOL ADDITIONAL INTERESTS UNDER ORDER NO. R-23006, EDDY COUNTY, NEW MEXICO

AMENDED APPLICATION

Alpha Energy Partners II, LLC ("Alpha" or "Applicant"), affiliate successor in interest in the Subject Lands to Alpha Energy Partners, LLC, through its undersigned attorneys, hereby files this Amended Application with the Oil Conservation Division ("Division") pursuant to the provisions of NMSA 1978, Section 70-2-17, for the specific purpose of (1) pooling additional uncommitted mineral interests under the terms of Division Order No. R-23006 (the "Order") which pooled uncommitted interest in the Wolfcamp formation underlying a 634.36-acres, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 19 and 20, Township 22 South, Range 27 East, Eddy County, New Mexico ("Subject Lands" under the Order); (2) advising the Division and affected parties that Alpha has entered into a farmout agreement with Paloma Permian AssetCO, LLC ("Paloma") by which Paloma has the right to earn a portion of Alpha's working interest in the Subject Lands by drilling, completing, and operating the proposed wells under the supervision of Alpha; and (3) providing notice for and approving wells which have undergone certain name changes and adjustments. In support of its Amended Application, Alpha states the following:

1. On January 10, 2024, the Division entered Order No. R-23006 in Case No. 22172, which pooled all uncommitted interests in the Wolfcamp formation underlying a 634.36-acre,

more or less, standard horizontal spacing unit comprised of the Subject Lands. The Order further dedicated the unit to The Dude 19/20 Fee 203H and The Dude 19/20 Fee 204H wells and designated Applicant as operator of the unit and wells.

2. Since the Order was entered, Applicant has identified additional uncommitted interests in the units that have not been pooled under the terms of the Order.

3. Applicant has undertaken diligent, good-faith efforts to obtain voluntary agreements from the additional interest owners but has been unable to obtain voluntary agreements from the owners.

4. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, the additional interests should be pooled into the unit pursuant to the terms of the Order.

5. On August 29, 2024, Alpha filed an Application to pool these uncommitted interests and the OCD docketed that Application as Case No. 24827.

6. On July 1, 2024, Alpha entered into a Farmout Agreement with Paloma, in which Paloma will receive a portion of Alpha's leasehold interest in the unit upon its fulfillment of certain drilling and operational obligations, and therefore Paloma will be involved in the unit by drilling and operating the wells in compliance with Alpha's development plans. Therefore, Alpha is designating Paloma, OGRID No. 332449, as the operator of the wells.

7. The Dude 19/20 Fee 203H Well, with a proposed surface hole location (SHL) in the SW/4 SW/4 (Unit M) of Section 21 to a bottom hole location (BHL) in the NW/4 SW/4 (Unit L) of Section 19, has been renamed and revised as **The Dude 20-19 Fee 702H**, which has an adjusted SHL in the SE/4 NE/4 (Unit H) and same quarter-quarter section, Lot 3 (NW/4 SW/4) (Unit L) for its BHL, the FTP and LTP being the NE/4 SE/4 (Unit I) and Lot 3 (Unit L),

respectively; the 702H remains orthodox; this well is re-dedicated to the spacing unit as The Dude 20-19 Fee 702H Well as an initial well.

8. The Dude 19/20 Fee 204H Well, with a proposed SHL in the SW/4 SW/4 (Unit M) of Section 21 to a BHL in Lot 4 (SW/4 SW/4) (Unit M) of Section 19, has been renamed and revised as **The Dude 20-19 Fee 701H Well**, which has an adjusted SHL in the SE/4 NE/4 (Unit H) and maintains the same quarter-quarter section (Lot 4, Unit M of Sec. 19) for its BHL; the 701H remains orthodox; this well is re-dedicated to the spacing unit as The Dude 20-19 Fee 701H Well as an initial well.

9. Alpha and Paloma have also updated their well proposals, the updates sent on October 31, 2024, to working interest owners in the unit, to include the 701H and 702H Wells and to propose one additional well for the lower part of the Wolfcamp formation: **The Dude 20-19 Fee 801H Well** with a SHL located in the SE/4 NE/4 (Unit H) of Section 20 and a BHL located in Lot 3 (NW/4 SW/4) (Unit L) of Section 19; the 801H Well is added and dedicated to the unit as an initial well, along with the 701H and 702H Wells. The completed interval of the 801H Well is orthodox.

WHEREFORE, Applicant requests this application be set for hearing before an Examiner of the Division on February 13, 2025, and, after notice and hearing the Division amend Order No. R-23006:

- A. To pool the additional uncommitted interests into the unit pursuant to the terms of Division Order No. R-23006
- B. To approve redesignating the 203H and 204H Wells as the 702H and 701H Well, as described above in Paragraphs 7 and 8 and as will be described in a revised Compulsory Pooling Checklist submitted for the hearing;

- C. To approve the 801H Wells as described above in Paragraph 9, and thereby approving costs of drilling and completion and a 200% risk penalty.
- D. To maintain the interests already pooled under Order No. R-23006 so that they remain pooled.
- E. To approve Paloma as the operator subject to the Farmout described herein.
- F. To maintain all the terms under Order No. R-23006, including but not limited to reimbursement of charges and costs to the operator and the 200% risk penalty.

Amended Application of Alpha Energy Partners II, LLC, to Pool Additional Interests under Order No. R-23007, Eddy County, New Mexico. Alpha Energy Partners II, LLC, affiliate successor to Alpha Energy Partners, LLC, ("Applicant"), in the above-styled cause seeks to amend Order No. R-23005 for the purpose of (1) pooling newly found additional uncommitted mineral interests under the terms of Division Order No. R-23006, issued in Case No. 22172, which pooled uncommitted interest in the Purple Sage Wolfcamp formation underlying a 634.36-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 19 and 20, Township 22 South, Range 27 East, Eddy County, New Mexico ("Subject Lands" under the Order); (2) advising the Division and affected parties that Alpha has entered into a farmout agreement with Paloma Permian AssetCO, LLC ("Paloma") by which Paloma, as the designated operator, has the right to earn a portion of Alpha's working interest in the Subject Lands by drilling, completing, and operating the proposed wells under the supervision of Alpha; and (3) providing notice for and approving wells which have undergone certain name changes and adjustments, to wit: The Dude 19/20 Fee 203H Well, with a proposed surface hole location (SHL) in the SW/4 SW/4 (Unit M) of Section 21 to a bottom hole location (BHL) in the NW/4 SW/4 (Unit L) of Section 19, has been renamed and revised as The Dude 20-19 Fee 702H, an initial well, which has an adjusted SHL in the SE/4 NE/4 (Unit H) and maintains the same quarter-quarter section (Lot 4, Unit M of Sec. 19) for its BHL; the 701H remains orthodox; and The Dude 19/20 Fee 204H Well, with a proposed SHL in the SW/4 SW/4 (Unit M) of Section 21 to a BHL in the SW/4 SW/4 (Unit M) of Section 19, has been renamed and revised as The Dude 20-19 Fee 701H Well, an initial well, which has an adjusted SHL in the SE/4 NE/4 (Unit H) and maintains the same quarter-quarter section (Lot 4, Unit M of Sec. 19) for its BHL; the 701H remains orthodox. Furthermore, Applicant proposes one additional well, as an initial well, for the lower part of the Wolfcamp formation: The Dude 20-19 Fee 801H Well with a SHL located in the SE/4 NE/4 (Unit H) of Section 20 and a BHL located in Lot 3 (NW/4 SW/4) (Unit L) of Section 19. Wells are orthodox pursuant to Order No. R-14262, governing Purple Sage setbacks. The terms of Order No. R-23006, that maintains the pooled interests, will inform the cost of drilling and completing the wells and the allocation of the costs thereof; actual operating costs and charges for supervision. The wells and lands are located approximately 1.6 miles southwest of Carlsbad, New Mexico.
