**NOTICE OF DISMISSAL AND STATEMENT OF SUPPORT**

Avant Operating, LLC, (“Avant”) by and through its undersigned counsel, hereby serves notice that an agreement between Avant and Magnum Hunter Production Company, Inc. (“MHPI”) has been reached, and the parties jointly request that Case Nos. 24632 and 24633 be dismissed.

Following the November 2024 hearing in the above cases, Coterra Energy (parent company of MHPI) acquired Avant, and as a result the balance of interests in the proposed units for both parties has evolved. Avant submits this notice of its support for MHPI’s proposed development plans for the Turnpike 33-32 State Com wells (“Plan”), on the basis that MHPI’s Plan demonstrates a commitment to preventing waste and protecting correlative rights by efficiently and fully developing the underlying acreage. Avant agrees with the ownership percentages and lists

provided in MHPI's exhibits and also concedes that lay down development is acceptable within the development area.
