STATEMENT OF THE CASES

In **Case No. 24997**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 6, Township 19 South, Range 28 East, and the N/2 N/2 of Section 1, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Terlingua 6-1 State Com 121H** and **Terlingua 6-1 State Com 131H** wells, which will produce from first take points in the NE/4 NE/4 (Unit A) of Section 6, Township 19

South, Range 28 East to last take points in the NW/4 NW/4 (Unit D) of Section 1, Township 19 South, Range 27 East.

In **Case No. 24998**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 6, Township 19 South, Range 28 East, and the N/2 S/2 of Section 1, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Terlingua 6-1 State Com 123H** and **Terlingua 6-1 State Com 133H** wells, which will produce from first take points in the NE/4 SE/4 (Unit I) of Section 6, Township 19 South, Range 28 East to last take points in the NW/4 SW/4 (Unit L) of Section 1, Township 19 South, Range 27 East.

In **Case No. 24999**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Section 6, Township 19 South, Range 28 East, and the S/2 S/2 of Section 1, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Terlingua 6-1 State Com 124H** and **Terlingua 6-1 State Com 134H** wells, which will produce from first take points in the SE/4 SE/4 (Unit P) of Section 6, Township 19 South, Range 28 East to last take points in the SW/4 SW/4 (Unit M) of Section 1, Township 19 South, Range 27 East.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
