In Case No. 24997, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 6, Township 19 South, Range 28 East, and the N/2 N/2 of Section 1, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the Terlingua 6-1 State Com 121H and Terlingua 6-1 State Com 131H wells, which will produce from first take points in the NE/4 NE/4 (Unit A) of Section 6, Township 19

South, Range 28 East to last take points in the NW/4 NW/4 (Unit D) of Section 1, Township 19 South, Range 27 East.

The unit will be dedicated to the **Terlingua 6-1 State Com 124H** and **Terlingua 6-1 State Com 134H** wells, which will produce from first take points in the SE/4 SE/4 (Unit P) of Section 6, Township 19 South, Range 28 East to last take points in the SW/4 SW/4 (Unit M) of Section 1, Township 19 South, Range 27 East.

The completed intervals of the wells will be orthodox.
