STATEMENT OF THE CASES

In **Case No. 25011**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 15 and 16, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Fosters 16-15 Fed Com 200H** well, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 17 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 15.

In **Case No. 25013**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 15 and 16, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Fosters 16-15 Fed Com 201H** well, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 17 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 15.

In **Case No. 25014**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 15 and 16, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Fosters 16-15 Fed Com 202H** well, which will be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 16 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 15.

In **Case No. 25015**, Permian Resources applies for an order an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 15 and 16, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Fosters 16-15 Fed Com 203H** well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 16 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 15.

In **Case No. 25018**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 15 and 16, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Fosters 16-15 Fed Com 133H** well,

which will be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 16 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 15.

In **Case No. 25019**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 15 and 16, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Fosters 16-15 Fed Com 134H** well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 16 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 15.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
