In **Case No. 25060**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 21 and 22, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Taipan 21 Fed Com 131H** well,

which will be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 20 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 22.

In **Case No. 25061**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 21 and 22, Township 20 South, Range 28 East, Eddy County, New Mexico. The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of
