## **STATEMENT OF THE CASES**

In **Case No. 25076**, Permian Resources applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 25 and the N/2 NE/4 of Section 26, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Boomerang 25 Fed Com 121H** well, which will produce from a first take

point in the NE/4 NE/4 (Unit A) of Section 25 to a last take point in the NW/4 NE/4 (Unit B) of Section 26.

In **Case No. 25077**, Permian Resources applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 25 and the S/2 NE/4 of Section 26, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Boomerang 25 Fed Com 122H** well, which will produce from a first take point in the SE/4 NE/4 (Unit H) of Section 25 to a last take point in the SW/4 NE/4 (Unit G) of Section 26.

In **Case No. 25078**, Permian Resources applies for an order pooling all uncommitted interests in the Second Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 25 and the SE/4 of Section 26, Township 20 South, Range 28 East, Eddy County, New Mexico. The unit will be dedicated to the **Boomerang 25 Fed Com 123H** "j-turn" well, which will produce from a first take point in the NE/4 SE/4 (Unit I) of Section 25 to a last take point in the SE/4 SE/4 (Unit P) of Section 26.

Due to a depth severance in the Bone Spring Formation within the unit, in Case Nos. 25076, 25077, and 25078, Applicant seeks to pool uncommitted interests in the Second Bone Spring interval only, from approximately 6,945' MD to 7,850' MD as shown on the Lee Federal Com #2 well log (API 30-015-24349).

The completed intervals of the Boomerang wells are expected to be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the \_

designation of Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
