**STATEMENT OF THE CASES**

In these cases, Permian Resources seeks to pool additional interests under the terms of Order Nos. R-23593, R-23594, R-23595, R-23596, R-23597, and R-23598.

On December 12, 2024, the Division entered Order No. R-23598 in Case No. 24863, which pooled uncommitted interests in the Third Bone Spring interval of the Bone Spring formation underlying a standard, overlapping, horizontal spacing unit comprised of the E/2 E/2 of Sections 23 and 26, Township 22 South, Range 34 East, Lea County, New Mexico. The order further dedicated the unit to the **Tour Bus 23 Fed Com 604H** well and designated Permian Resources as operator of the unit and well.

In **Case No. 25127**, Permian Resources seeks to pool additional interests under the terms of Order No. R-23597.
