STATEMENT OF THE CASE

Spur applies for an order pooling all uncommitted interests from the top of the Yeso formation to 5,000’ MD underlying a 157.38-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of irregular Section 7, Township 17 South, Range 30 East, Eddy County, New Mexico (“Unit”). Spur seeks to dedicate the Unit to the **Merak 7 Federal Com 20H** well (API No. 30-015-49092) (“Well”), to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 8 to a bottom hole location in Lot 1 (NW/4 NW/4 equivalent) of Section 7. Due to a depth severance within the Unit, Applicant seeks to pool uncommitted interests in the Yeso formation from the stratigraphic equivalent of 4,225’ MD to 5,000’ MD as observed on the

Anderson-Federal 1 well Schlumberger Sidewall Neutron Porosity Log (API No. 30-015-20565).
The completed interval of the Well will be orthodox. Spur has reached agreements with all working interest owners and is only seeking to pool overriding royalty interests.
