APPLICANT’S STATEMENT OF THE CASE

Under these consolidated cases, Mewbourne seeks to reopen the existing orders and pool additional mineral owners underlying the referenced acreage, all in Township 20 South, Range 36 East, NMPM, Lea County, New Mexico, as follows:

- In **Case 25279**, Mewbourne seeks to amend pooling Order No. R-23640 (“Pooling Order”). On January 15, 2025, the Division entered Order No. R-23640 in Case No. 24845, pooling the uncommitted interest owners in the Bone Spring formation (Featherstone; Bone Spring, East Pool [24270]) underlying a standard 315.08-acre, more or less, horizontal well spacing unit comprised of Lots 1-4 (W/2 W/2 equivalent) of irregular Sections 7 and 18. Mewbourne is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the **Goat Rope 7/18 State Com #521H** (API: 30-025-53329) well.
- In **Case 25280**, Mewbourne seeks to amend pooling Order No. R-23641 (“Pooling Order”). On January 15, 2025, the Division entered Order No. R-23641 in Case No. 24846, pooling the uncommitted interest owners in the Bone Spring formation (Featherstone; Bone Spring, East Pool [24270]) underlying a standard 320-acre, more or less, horizontal well spacing unit comprised of the E/2 W/2 of Sections 7 and 18.

Mewbourne is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the **Goat Rope 7/18 State Com #523H** (API: 30-025-53330) well.

- In **Case 25281**, Mewbourne seeks to amend pooling Order No. R-23642 (“Pooling Order”). On January 15, 2025, the Division entered Order No. R-23642 in Case No. 24847, pooling the uncommitted interest owners in the Bone Spring formation (Featherstone; Bone Spring, East Pool [24270]) underlying a standard 320-acre, more or less, horizontal well spacing unit comprised of the W/2 E/2 of Sections 7 and 18. Mewbourne is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the **Goat Rope 7/18 State Com #525H** (API: 30-025-53331) well.

Applicant has discovered additional mineral owners in the pooled acreage that were not subject to the pooling proceedings giving rise to Order Nos. R-23640-23642. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from these additional mineral owners.
