EOG Resources, Inc. ("EOG" or "Applicant") (OGRID No. 7377) through its undersigned attorneys, files this application with the Oil Conservation Division for an order pooling all uncommitted mineral owners in a non-standard 1,280-acre, more or less, horizontal well spacing unit in the Bone Spring formation comprised of the Sections 12 and 13, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico. In support of this application, EOG states:

1. EOG is a working interest owner in the subject acreage and has the right to drill thereon.
2. 3. Applicant plans to file a separate administrative application for approval of the non-standard spacing unit.

4. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the subject spacing unit.

5. The pooling of interests and approval of this spacing unit will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this matter be set for hearing on October 9, 2025, before an Examiner of the Oil Conservation Division, and, after notice and hearing as required by law, the Division enter an order:

A. Pooling all uncommitted interest owners in the proposed horizontal well spacing unit;

- B. Designating Applicant as operator of this horizontal spacing unit and the horizontal wells to be drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, equipping, and completing the wells;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- E. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the wells against any working interest owner who does not voluntarily participate in the drilling of the wells.

SELF-AFFIRMED STATEMENT OF LACI STRETCHER

1. My name is Laci Stretcher. I work for EOG Resources, Inc. ("EOG") as a Landman.
2. I have previously testified before the New Mexico Oil Conservation Division ("Division") as an expert witness in petroleum land matters, and my credentials have been accepted as a matter of record.
3. I am familiar with the application filed by EOG in this case, and I am familiar with the status of the lands in the subject area.
4. None of the uncommitted parties in this case have indicated opposition to proceeding by self-affirmed statement and, therefore, I do not expect any opposition at the hearing.
5. Under **Case No. 25627**, EOG seeks to pool the uncommitted interests in the Bone Spring formation underlying a non-standard 1,280-acre, more or less, horizontal well spacing unit comprised of All of Sections 12 and 13, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico, and initially dedicates the unit to the proposed **Margie 24 Federal Com 501H** and **Margie 24 Federal Com 511H** wells, both to be horizontally drilled from surface locations in the NW/4 NW/4 (Unit D) of Section 24, and bottom hole locations in the NW/4 NW/4 (Unit D) of Section 12; **Margie 24 Federal Com 502H** well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 24, and a bottom hole location in the NW/4 NW/4 (Unit D) of Section 12; **Margie 24 Federal Com 503H** well, to be horizontally drilled from a surface

6. Applicant plans to file separate administrative applications for approval of the non-standard spacing units.

7. **EOG Exhibit C-1** contains C-102s for the proposed wells. The wells are dedicated to the Salt Lake; Bone Spring [53560]. This form demonstrates that the completed interval of the wells will comply with the state setback requirements for the Bone Spring formation.

8. **EOG Exhibit C-2** identifies the tracts of land comprising the horizontal spacing unit, the ownership interests in each tract, and ownership interests on a spacing unit basis. The parties EOG seeks to pool are highlighted in yellow.

9. **EOG Exhibit C-3** contains a sample of the well proposal letter and AFEs sent to owners with a working interest. The costs reflected in the AFEs are consistent with what EOG and other operators have incurred for drilling similar horizontal wells in the area in this formation.

10. EOG requests that the overhead and administrative costs for drilling and producing the proposed wells be set at \$12,000 per month while drilling and \$2,000 per month while producing. These costs are consistent with what other operators are charging in this area for similar wells.

11. **EOG Exhibit C-4** contains a general summary of the contacts with the uncommitted interest owners. As indicated in the exhibit, EOG has made a good faith effort to locate and has had communications with all of the parties that it seeks to pool in this case in an effort to reach voluntary joinder. In my opinion, EOG has undertaken good faith efforts to reach an agreement with the uncommitted interest owners.

12. EOG has provided the law firm of Holland & Hart LLP with the names and addresses of the parties that EOG seeks to pool and instructed that they be notified of this hearing. EOG has conducted a diligent search of all public records in the county where the property is located, reviewed telephone directories, and conducted computer searches to locate contact information for each interest owner.

13. **EOG Exhibit C-1 through C-4** were either prepared by me or compiled under my direction and supervision.

14. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.

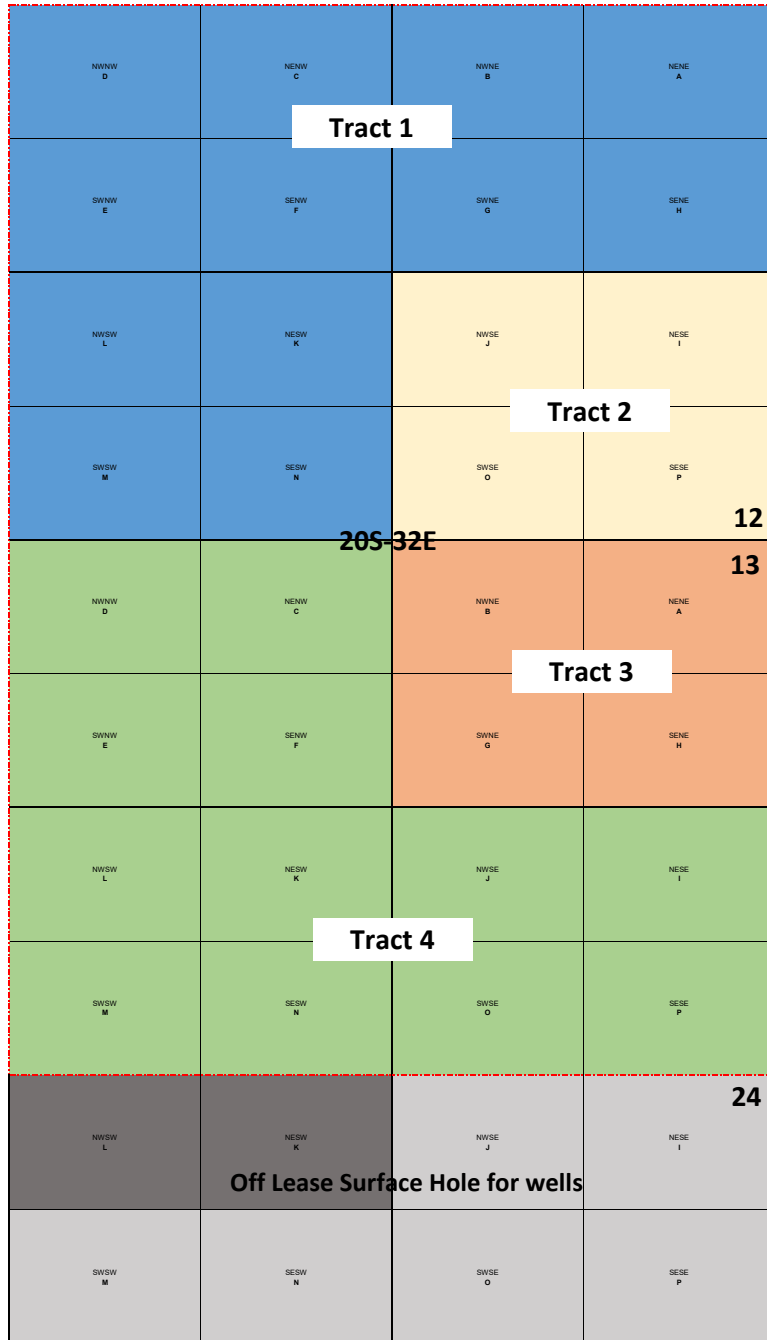

SELF-AFFIRMED STATEMENT OF TERRA GEORGE

1. My name is Terra George, and I am employed by EOG Resources, Inc. (“EOG”) as a petroleum geologist.

2. I have previously testified before the New Mexico Oil Conservation Division (“Division”) as an expert witness in petroleum geology. My credentials as an expert in petroleum geology have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by EOG in this case, and I have conducted a geologic study of the lands in the subject area. EOG is targeting the Bone Spring formation in this case.

4. **EOG Exhibit D-1** is a general locator map.

5. **EOG Exhibit D-2** is a subsea structure map that I prepared for the Bone Spring. The contour intervals are 100 feet. The area comprising the proposed spacing unit is outlined in red, and a grey arrow shows the direction of the proposed wells. The structure map shows the targeted formation gently dipping to the southeast. The structure appears consistent across the proposed spacing unit, and I do not observe any faulting, pinch outs, or other geologic impediments to drilling horizontal wells.

6. EOG Exhibit D-2 also shows a solid black line of cross-section through the proposed horizontal spacing unit from A to A’. I chose the logs from these wells to create the

cross-section because they penetrate the targeted interval, are of good quality, and have been subjected to petrophysical analysis of the targeted interval. In my opinion, these well logs are representative of the geology in the subject area.

7. **EOG Exhibit D-3** is a stratigraphic cross-section that I prepared using the logs from the representative wells shown on Exhibit D-2. The wells on the cross-section contain a combination of gamma ray, resistivity, and porosity logs. The target intervals for the initial wells are marked on the cross section with a blue arrow. The cross-section demonstrates that the targeted intervals are continuous across the proposed spacing unit.

8. In my opinion, standup orientation of the proposed wells is the appropriate orientation for horizontal well development in this area.

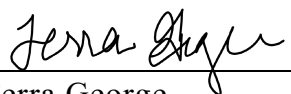
9. Based on my geologic study, the Bone Spring formation underlying the subject area is suitable for development by horizontal wells and the acreage comprising the proposed spacing unit will contribute more-or-less equally to the production from the wellbore. I have not identified any geologic impediments to drilling horizontal wells in the area of the spacing unit proposed.

10. In my opinion, horizontal drilling will be the most efficient method to develop this acreage, to prevent the drilling of unnecessary wells, and to result in the greatest ultimate recovery, and that approving EOG's application will be in the best interest of conservation, the prevention of waste, and protection of correlative rights.

11. **EOG Exhibits D-1 through D-3** were either prepared by me or compiled under my direction and supervision.

12. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be

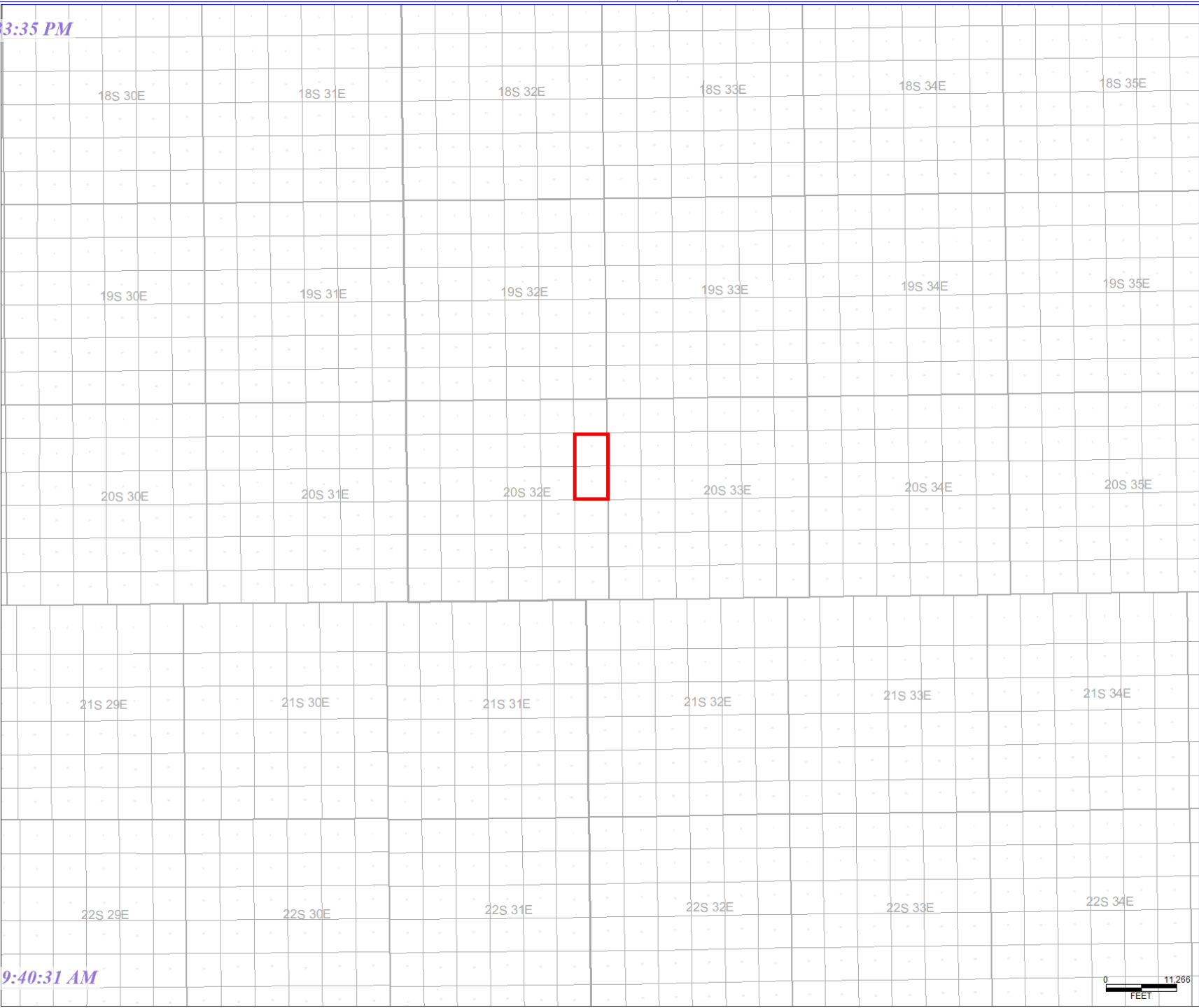
