Order No. R-23689 pooled all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit, comprised of the

W/2 W/2 of Sections 11 and 14, Township 20 South, Range 33 East, Lea County, New Mexico. Order No. R-23689 further dedicated the unit to the Anaconda Federal Com 111H well.

In **Case No. 25720**, Permian Resources requests a one-year extension of time, until February 19, 2027, to commence drilling the wells authorized by Order No. R-23690. Order No. R-23690 pooled all uncommitted interests in the First Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit, comprised of the E/2 W/2 of Sections 11 and 14, Township 20 South, Range 33 East, Lea County, New Mexico. Order No. R-23690 further dedicated the unit to the Anaconda Federal Com 112H well.

Order No. R-23694 pooled all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit, comprised of the E/2 W/2 of Sections 11 and 14, Township 20 South, Range 33 East, Lea County, New Mexico. Order No. R-23694 further dedicated the unit to the Anaconda Federal Com 202H well.

A one-year extension of time to commence drilling the Anaconda Wells has been requested as Permian Resources' ability to commence drilling the Anaconda Wells has been impacted by permitting delays and rig availability. Therefore, good cause exists for the requested extensions.
