EDDY COUNTY, NEW MEXICO.**

**APPLICATION**

Chase Oil Corporation (“Chase” or “Applicant”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to amend Pooling Order R-23184, as amended, to (a) add a previously pooled party back to the pooling order, and (b) extend the drilling deadline. In support of its application, Chase states:

1. On May 1, 2024, the Division entered Order No. R-23184 (“Order”), pooling the uncommitted interests in the San Andres formation (WC 16S27E32; San Andres [98371]) underlying the W/2 W/2 of Section 29, Township 16 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”), and designated Mack Energy Corporation (OGRID 13837) as operator of the Unit. This standard 160-acre, more or less, horizontal spacing unit is initially dedicated to the proposed **Anchorage Fed Com 1H** (API No. 30-015-55366).
2. On June 18, 2025, the Division issued Order No. R-23184-A, extending the period to drill the well until May 1, 2026.
3. Applicant requires re-pooling a party previously pooled under Order R-23184 that was later dropped because an agreement was reached between the parties; however, is currently no longer committed to a voluntary agreement.

4. Additionally, there is good cause for Applicant's request for an extension of time to drill.

5. Under the amended Order, Applicant would be required to commence drilling the well by May 1, 2026, and therefore, asks for the deadline to commence drilling the well be extended for a year, to May 1, 2027.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on March 5, 2026, and, after notice and hearing as required by law, the Division enter an order pooling the additional interest owner under the terms of Order R-23184, as amended, and extending the time for Applicant to commence drilling the proposed initial well under the amended Order.

CASE \_\_\_\_\_: **Application of Chase Oil Corporation to Amend Order No. R-23184, As Amended, to Add Additional Pooled Parties and Extend the Drilling Deadline, Eddy County, New Mexico.** Applicant in the above-styled cause seeks to amend Pooling Order R-23184, as amended, to (a) add a previously pooled party back to the pooling order, and (b) extend the drilling deadline. The Unit is comprised of the W/2 W/2 of Section 29, Township 16 South, Range 27 East, NMPM, Eddy County, New Mexico. Order No. R-23184 pooled the uncommitted interests in the San Andres formation and dedicated the Unit to the proposed initial **Anchorage Fed Com 1H** (API No. 30-015-55366), to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 32, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 29. Said area is located approximately 6 miles northeast of Artesia, New Mexico.
