XTO HOLDINGS, LLC'S BRIEF ON LACK OF NOTICE

In accordance with the Pre-Hearing Order dated January 23, 2026, XTO Holdings, LLC ("XTO") submits its Brief on Lack of Notice. As demonstrated below, Riley Permian Operating Company, LLC ("Riley") failed to notify XTO of Riley's pooling applications or the New Mexico Oil Conservation Division's ("Division") hearings in Case Nos. 25047, 25048, 25049, and 25358. Accordingly, XTO requests that the Division reopen these cases to afford XTO its legal right to notice and a hearing on Riley's applications and the opportunity to voluntarily participate in the approved wells.

I. UNDISPUTED MATERIAL FACTS

Case No. 25047

1. On December 9, 2024, Riley filed an Application for an order pooling uncommitted interests in the Yeso formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 33, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico.¹ Riley sought to dedicate the Unit to the Eagle 33 Fed Com #004H and Eagle 33 Fed Com #005H wells.²

2. XTO is a working interest owner in the unit and was entitled to notice of the application and hearing in Case No. 25047.³

3. In its Application, Riley represented that it “sought in good faith but [was] unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.”⁴

4. On October 30, 2024, Riley sent its well proposal letter to XTO.⁵ Tracking information indicates that it was delivered to a P.O. Box in Dallas, Texas on November 4, 2024.⁶ XTO’s mailing address is neither a P.O. Box nor located in Dallas, Texas.⁷

5. On February 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley’s exhibits into the record, including Riley’s notice affidavit, which was identified as Exhibit E. Riley’s Exhibit E reflects that notice of the hearing

was sent to P.O. Box 840780, Dallas, TX 75284, which is not XTO's address.⁸

6. The certified mail return receipt was signed by "Waymond Harvey."⁹ There is no record of Waymond Harvey being employed by XTO.¹⁰

7. Riley did not make any other efforts to communicate with XTO apart from sending the well proposal letter and notice of application to the incorrect address via certified mail.¹¹

8. The Division entered Order No. R-23729 in Case No. 25047 on February 19, 2025.¹²

9. Following issuance of the Order, Riley e-mailed a copy of the Order to an XTO landman.¹³ In the email string, XTO's landman, Chad Smith, expressed concern that XTO never received the original proposals.¹⁴

10. In response, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing.¹⁵ Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed.¹⁶

Case No. 25048

11. On December 9, 2024, Riley filed an Application for an order pooling uncommitted interests in the Yeso formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 33, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico.¹⁷ Riley sought to dedicate the Unit to the Eagle 33 Fed Com #007H and

Eagle 33 Fed Com #008H wells.¹⁸

12. XTO is a working interest owner in the unit and was entitled to notice of the application and hearing in Case No. 25048.¹⁹

13. In its Application, Riley represented that it “sought in good faith but [was] unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.”²⁰

14. On October 30, 2024, Riley sent its well proposal letter to XTO.²¹ Tracking information indicates that it was delivered to a P.O. Box in Dallas, Texas on November 4, 2024.²² XTO’s mailing address is neither a P.O. Box nor located in Dallas, Texas.²³

15. On February 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley’s exhibits into the record, including Riley’s notice affidavit, which was identified as Exhibit E. 18. The Division entered Order No. R-23730 in Case No. 25048 on February 19, 2025.²⁸

19. Following issuance of the Order, Riley e-mailed a copy of the Order to an XTO landman.²⁹ In the email string, XTO's landman, Chad Smith, expressed concern that XTO never received the original proposals.³⁰

20. In response, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing.³¹ Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed.³²

Case No. 25049

21. On December 9, 2024, Riley filed an Application for an order pooling uncommitted interests in the Yeso formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 33, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico.³³ Riley sought to dedicate the Unit to the Eagle 33 Fed Com #010H and Eagle 33 Fed Com #011H wells.³⁴

22. XTO is a working interest owner in the unit and was entitled to notice of the application and hearing in Case No. 25049.³⁵

23. In its Application, Riley represented that it "sought in good faith but [was] unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their

interests to the wells.”³⁶

24. On October 30, 2024, Riley sent its well proposal letter to XTO.³⁷ Tracking information indicates that it was delivered to a P.O. Box in Dallas, Texas on November 4, 2024.³⁸ XTO’s mailing address is neither a P.O. Box nor located in Dallas, Texas.³⁹

30. In response, XTO requested that it be permitted to participate in the development

instead of being treated as a pooled party because it had never received notice of the hearing.⁴⁷

Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed.⁴⁸

Case No. 25358

31. On April 8, 2025, Riley filed an Application for an order pooling uncommitted interests in the Yeso formation underlying a 481.47-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Section 12, Township 18 South, Range 26 East, NMPM, and the NW/4 of Section 7, Township 18 South, Range 27 East, NMPM, Eddy County, New Mexico.⁴⁹ Riley sought to dedicate the Unit to the Marty Fee 11-7 1H, Marty Fee 11-7 2H, Marty Fee 11-7 3H, and Marty Fee 11-7 4H wells.⁵⁰

32. XTO is a working interest owner in the unit and was entitled to notice of the application and hearing in Case No. 25358.⁵¹

33. In its Application, Riley represented that it "sought in good faith but [was] unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells."⁵²

34. On July 10, August 7, and August 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley's exhibits into the record, including Riley's notice affidavit, which was identified as Exhibit E. Exhibit E reflects that notice of the hearing was sent to P.O. Box 840780, Dallas, TX 75284, which is not XTO's address.⁵³

35. Although the name itself is illegible, the certified mail return receipt indicates that

the same individual signed for the mailings to both XTO and EOG Resources, Inc.⁵⁴

36. As set out in its chronology of contact, Riley sent the well proposal letter to the incorrect address via certified mail. Riley subsequently emailed XTO's landman the well proposal letter.⁵⁵ However, Riley never emailed a copy of the pooling application or hearing notice to XTO's landman.

37. The Division entered Order No. R-23990 in Case No. 25358 on September 8, 2025.⁵⁶ Following the issuance of the Order, Riley e-mailed a copy of the Order to an XTO landman.⁵⁷

38. In response, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing.⁵⁸ Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed.⁵⁹

XTO's Address

39. XTO's mailing address is 22777 Springwoods Village Parkway, Spring, TX 77389.⁶⁰ XTO's correct mailing address can be gleaned from a simple internet search or from the email signatures of XTO employees with whom Riley frequently communicated.⁶¹

II. ARGUMENT

a. Riley failed to engage in good faith negotiations with XTO.

Section 70-2-17(C) of the Oil and Gas Act⁶² states that:

All orders effecting [compulsory] pooling shall be made after notice and hearing, and shall be upon such terms and conditions as are just

and reasonable and will afford to the owner or owners of each tract or interest in the unit the opportunity to recover or receive without unnecessary expense his just fair share of the oil or gas, or both.

Riley claimed at the original hearings of these matters that it “sought in good faith but has been unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.” *See* Undisputed Material Facts (“UMF”) Nos. 3, 13, 23, 33. However, Riley did not “exercise reasonable diligence” as it did not actually send its well proposal letters to the correct mailing address for XTO. *See* UMF No. 4, 14, 24. Due to this lack of notice, XTO did not have the opportunity to consent to participate in these Riley wells. When XTO contacted Riley and informed them of the failure of notice and its desire to participate in the wells, Riley insisted that XTO bear the 200% risk penalty instead. *See* UMF No. 9-10, 19-20, 29-30. As a result, XTO has been deprived of its statutory right to recover or receive its just fair share of oil and gas without unnecessary expense. Riley clearly did not satisfy the statutory and regulatory prerequisites to compulsory pooling, and this matter should be reopened and set for a hearing.

b. Riley failed to provide XTO with the required notice of its applications and the Division’s hearings because it sent the notices to the wrong address.

The Division’s Rules specifically state that the failure to provide adequate notice for a compulsory pooling application is grounds for reopening a case: “Evidence of failure to provide notice as 19.15.4.9 NMAC requires may, upon proper showing, be considered cause for reopening the case.” 19.15.4.12(D) NMAC. A compulsory pooling applicant “shall give notice to each owner of an interest in the mineral estate of any portion of the lands the applicant proposes to be pooled or unitized whose interest is evidenced by a written conveyance document either of record *or known to the applicant at the time the applicant filed the application....*” Rule 19.15.4.12(1)(a) NMAC (emphasis added). Rule 19.15.4.12(B) requires that the notice be sent by “certified mail,

return receipt requested, to the last known address of the person to whom notice is to be given at least 20 days prior to the application's scheduled hearing date[.]”

Notice that does not satisfy the Division's notice requirements is defective and renders an order void. *Johnson v. N.M. Oil Conserv. Comm'n*, 1999-NMSC-021, ¶ 3, 127 N.M. 120, 978 P.2d 327 (holding that the Oil Conservation Commission's order was invalid as to parties without actual notice). For example, in Case No. 22323, the applicant (a working interest owner) moved to reopen a prior pooling case on the grounds that the operator failed to send notice of the compulsory pooling proceeding to the correct address. *See* Order No. R-22240, ¶¶ 23. The Division ordered that the matter be reopened on the grounds that the operator failed to provide adequate notice as required by Division rules. *Id.* at ¶ 27. As recognized by the Division in that case, “[d]emonstrating the failure to comply with the [notice] requirement for ‘reasonable diligence’ can be the ‘proper showing’ necessary to establish cause for reopening a case.” *See* Order R-22240 at ¶ 18. “Reasonable diligence” has been defined by the New Mexico Court of Appeals as an action that an “individual of ordinary prudence would undertake under the circumstances in order to be successful.” *See Fulton v. Cornelius*, 1988-NMCA-057, ¶ 21, 107 N.M. 362, 758 P.2d 312.

The exhibits filed by Riley in each of the underlying cases show when and to whom notice was sent. For each of the applications, the certified mail receipts show that notice was sent to XTO at P.O. Box 840780, Dallas, TX 75284. *See* UMF No. 5, 15, 25, 34. However, that is not XTO's mailing address. *See* UMF No. 39. XTO's mailing address is 22777 Springwoods Village Parkway, Spring, TX 77389. *See id.* It is unknown how Riley determined that a Dallas post office box would be used to provide notice of the pooling applications to XTO, but “reasonable diligence” required a simple internet search or reference to the email signatures of the XTO employees with whom Riley regularly communicated to locate the correct address in Spring, Texas. XTO's address was

clearly “known to the applicant at the time the applicant filed the application” but Riley did not use it. 19.15.4.12(A)(1)(a) NMAC. Therefore, Riley did not comply with the Division’s notice requirements.

In addition, the certified mail receipts were not signed by an employee of XTO. *See* UMF No. 6, 16, 26. That the same person signed one of the receipts for EOG further demonstrates this fact. EOG and XTO do not share employees. *See* UMF No. 35.

While Riley might argue that it provided a well proposal and opportunity to participate in the wells after the Orders were issued, that “does not erase the claims of injury that flow from the...failure to notify [XTO] of the hearing process.” *See* Order No. R-22240 at ¶ 15 (finding that an interest owner’s failure to receive notice of the hearing results in an injury “not only for the inability to consider participation in the well but also for the inability to raise issues, such as the amount of the risk charge, at the hearing”). XTO was denied an opportunity to enter an appearance and object to Riley’s pooling applications; was denied the opportunity to raise issues before the Division regarding Riley’s pooling applications; and was ultimately denied due process protections while its property rights were affected. The only remedy for this error is to reopen the cases so that XTO may receive proper notice and be afforded the opportunity to participate in the hearings. *See Uhden v. N.M. Oil Conservation Comm’n*, 1991-NMSC-089, ¶ 31, 112 N.M. 528, 817 P.2d 721.

c. Riley’s failure to provide proper notice violated XTO’s right to due process.

In *Uhden*, the New Mexico Supreme Court set forth the due process requirements of fairness and reasonableness for pooling proceedings, noting that “[a]dministrative proceedings must conform to fundamental principles of justice and the requirements of due process of law.” *Id.* at ¶ 10. In accordance with these principles, the *Uhden* court noted that New Mexico case law places “great emphasis” on “whether the identity and whereabouts of the person entitled to notice

are reasonably ascertainable.” *Id.* at ¶ 13. Notice and an opportunity to be heard are basic constitutional protections of the due process clause. *Id.* at ¶ 12. The failure to provide required notice renders an order void. *See Johnson*, 1999-NMSC-021, ¶ 3 (holding that the Oil Conservation Commission’s order was invalid as to parties without actual notice).

Here, XTO’s correct address was easily ascertainable through XTO’s prior e-mail communications with Riley’s landman and is also readily available on the internet. *See* UMF No. 39. Despite this, Riley sent the notices in all four matters to the wrong address. *See* UMF Nos. 5, 15, 25, 34. Moreover, XTO received no other communication from Riley notifying XTO of the hearings, despite Riley having a working e-mail address for an XTO landman. Riley’s failure to meet the notice requirements outlined in Rule 19.15.4.12 NMAC violated XTO’s right to due process and mandates reopening of all four cases.

III. CONCLUSION

For the foregoing reasons, XTO respectfully requests that the Division reopen Case Nos. 25047-25049 and 25358 to remedy Riley’s failure of notice and provide XTO with the opportunity to exercise its right to participate in Riley’s units.

SELF-AFFIRMED STATEMENT OF CHAD SMITH

1. I am a Landman with XTO Holdings, LLC (“XTO”), an ExxonMobil subsidiary. I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division (“Division”), and my credentials as an expert in petroleum land matters were accepted and made a matter of record.

2. I am familiar with Division Case Nos. 25047-25049 and 25358 as well as related Division Order Nos. R-23729 to R-23731, and R-23990 (the “Orders”). Regarding the issue of notice to XTO, a summary of relevant proceedings is set out below.

EXHIBIT A

Case No. 25047

3. On December 9, 2024, Riley filed an Application for an order pooling uncommitted interests, in the Yeso formation, underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 33, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico. Riley sought to dedicate the Unit to the Eagle 33 Fed Com #004H and Eagle 33 Fed Com #005H wells. A copy of the Application is attached as **Exhibit A-1**.

4. XTO is a working interest owner in the unit. See Notice of Second Amended Exhibit Packet, Exh. C-4, attached as **Exhibit A-2**.

5. In its Application, Riley represented that it “sought in good faith but has been unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.” **Exhibit A-1** at ¶ 5.

6. On October 30, 2024, Riley sent its well proposal letter to XTO. See Notice of Second Amended Exhibit Packet, Exh. C-8, attached as **Exhibit A-3**. Tracking information indicates that it was delivered to a P.O. Box in Dallas, Texas on November 4, 2024. See United States Postal Service Tracking, attached as **Exhibit A-4**. XTO’s mailing address is neither a P.O. Box nor located in Dallas, Texas.

7. On February 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley’s exhibits into the record, including Riley’s notice affidavit, which was identified as Exhibit E. Riley’s Exhibit E identifies XTO’s mailing address as P.O. Box 840780, Dallas, TX 75284, which is not XTO’s address. See Notice of Second Amended Exhibit Packet, Exhibit E, attached as **Exhibit A-5**.

8. The certified mail return receipt indicates that the mailing was signed for by “Waymond Harvey.” **Exhibit A-5**. There is no record of Waymond Harvey being employed by XTO.

9. Riley did not make any other efforts to communicate with XTO apart from sending the well proposal letter and notice of application to the incorrect address via certified mail. *See Exhibits A-3, A-4, & A-5*.

10. The Division entered Order No. R-23729 in Case No. 25047 on February 19, 2025.

11. Following the issuance of the Order, Riley e-mailed a copy of the Order to an XTO landman. *See* Email String between Mark Smith and Chad Smith (03/06/2025 to 03/19/2025), attached as **Exhibit A-6**.¹ In the email string, XTO’s landman, Chad Smith, expressed concern that XTO never received the original proposals. *Id.*

12. In response, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing. *See* Email from Cindy Sloan to Mark Smith (Apr. 4, 2025), attached as **Exhibit A-7**; Letter from Chad Smith to Mark Smith (Nov. 19, 2025), attached as **Exhibit A-8**. Riley denied XTO’s request on the grounds that the time to voluntarily participate had lapsed. *See* Letter from Mark Smith to Chad Smith (Nov. 21, 2025), attached as **Exhibit A-9**.

Case No. 25048

13. On December 9, 2024, Riley filed an Application for an order pooling uncommitted interests, in the Yeso formation, underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 33, Township 17 South, Range 27 East, NMPM, Eddy

County, New Mexico. Riley sought to dedicate the Unit to the Eagle 33 Fed Com #007H and Eagle 33 Fed Com #008H wells. A copy of the Application is attached as **Exhibit A-10**.

14. XTO is a working interest owner. *See* Notice of Second Amended Exhibit Packet, Exhibit C-4, attached as **Exhibit A-11**.²

15. In its Application, Riley represented that it “sought in good faith but has been unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.” **Exhibit A-10** at ¶ 5.

16. On October 30, 2024, Riley sent its well proposal letter to XTO. *See* Notice of Second Amended Exhibit Packet, Exhibit C-8, attached as **Exhibit A-12**. Tracking information indicates that it was delivered to a P.O. Box in Dallas, Texas on November 4, 2024. *See* United States Postal Service Tracking, attached as **Exhibit A-13**. XTO’s mailing address is neither a P.O. Box nor located in Dallas, Texas.

17. On February 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley’s exhibits into the record, including Riley’s notice affidavit, which was identified as Exhibit E. Riley’s Exhibit E identifies XTO’s mailing address as P.O. Box 840780, Dallas, TX 75284, which is not XTO’s address. *See* Notice of Second Amended Exhibit Packet, Exhibit E, attached as **Exhibit A-14**.

18. The certified mail return receipt indicates that the mailing was signed for by “Waymond Harvey.” **Exhibit A-14**. There is no record of Waymond Harvey being employed by XTO.

19. Riley did not make any other efforts to communicate with XTO apart from sending the well proposal letter and notice of application to the incorrect address via certified mail. *See Exhibits A-12, A-13, & A-14.*

20. The Division entered Order No. R-23730 in Case No. 25048 on February 19, 2025.

21. Following the issuance of the Order, Riley e-mailed a copy of the Order to an XTO landman. *See* Email String between Mark Smith and Chad Smith (03/06/2025 to 03/19/2025), attached as **Exhibit A-6**. In the email string, XTO's landman, Chad Smith, expressed concern that XTO never received the original proposals. *Id.*

22. In response, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing. *See Exhibits A-7, A-8.* Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed. *See Exhibit A-9.*

Case No. 25049

23. On December 9, 2024, Riley filed an Application for an order pooling uncommitted interests, in the Yeso formation, underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 33, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico. Riley sought to dedicate the Unit to the Eagle 33 Fed Com #010H and Eagle 33 Fed Com #011H wells. A copy of the Application is attached as **Exhibit A-15**.

24. XTO is a working interest owner. *See* Notice of Second Amended Exhibit Packet, Exhibit C-4, attached as **Exhibit A-16**.³

25. In its Application, Riley represented that it "sought in good faith but has been unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying

the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.” **Exhibit A-15** at ¶ 5.

26. On October 30, 2024, Riley sent its well proposal letter to XTO. *See* Notice of Second Amended Exhibit Packet, Exhibit C-8, attached as **Exhibit A-17**. Tracking information indicates that it was delivered to a P.O. Box in Dallas, Texas on November 4, 2024. *See* United States Postal Service Tracking, attached as **Exhibit A-18**. XTO’s mailing address is neither a P.O. Box nor located in Dallas, Texas.

27. On February 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley’s exhibits into the record, including Riley’s notice affidavit, which was identified as Exhibit E. Riley’s Exhibit E identifies XTO’s mailing address as P.O. Box 840780, Dallas, TX 75284, which is not XTO’s address. Notice of Second Amended Exhibit Packet, Exhibit E, attached as **Exhibit A-19**.

28. The certified mail return receipt indicates that the mailing was signed for by “Waymond Harvey.” **Exhibit A-19**. There is no record of Waymond Harvey being employed by XTO.

29. Riley did not make any other efforts to communicate with XTO apart from sending the well proposal letter and notice of application to the incorrect address via certified mail. *See Exhibits A-17, A-18, & A-19*.

30. The Division entered Order No. R-23731 in Case No. 25049 on February 19, 2025.

31. Following the issuance of the Order, Riley e-mailed a copy of the Order to an XTO landman. *See* Email String between Mark Smith and Chad Smith (03/06/2025 to 03/19/2025), attached as **Exhibit A-6**. In the email string, XTO’s landman, Chad Smith, expressed concern that XTO never received the original proposals. *Id.*

32. In response, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing. *See Exhibits A-7, A-8.* Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed. *See Exhibit A-9.*

Case No. 25358

33. On April 8, 2025, Riley filed an Application for an order pooling uncommitted interests, in the Yeso formation, underlying a 481.47-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Section 12, Township 18 South, Range 26 East, NMPM, and the NW/4 of Section 7, Township 18 South, Range 27 East, NMPM, Eddy County, New Mexico. Riley sought to dedicate the Unit to the Marty Fee 11-7 1H, Marty Fee 11-7 2H, Marty Fee 11-7 3H, and Marty Fee 11-7 4H wells. A copy of the Application is attached as **Exhibit A-20**.

34. XTO is a working interest owner. *See* Notice of Second Amended Exhibit Packet, Exhibit C-4, attached as **Exhibit A-21**.

35. In its Application, Riley represented that it "sought in good faith but has been unable to obtain voluntary agreement from all interest owners in the Yeso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells." **Exhibit A-20** at ¶ 5.

36. On July 10, August 7, and August 13, 2025, Riley presented the case by affidavit to the Division. During the hearing, the Division admitted Riley's exhibits into the record, including Riley's notice affidavit, which was identified as Exhibit E. Exhibit E identifies XTO's mailing address as P.O. Box 840780, Dallas, TX 75284, which is not XTO's address. Notice of Second Amended Exhibit Packet, Exhibit E, attached as **Exhibit A-22**.

37. Although the name itself is illegible, the certified mail return receipt indicates that the same individual signed for the mailings to both XTO and EOG Resources, Inc. **Exhibit A-22**.

38. As set out in its chronology of contact, Riley sent the well proposal letter to the incorrect address via certified mail, but subsequently emailed XTO's landman regarding the proposal. Notice of Second Amended Exhibit Packet, Exhibit C-6, attached as **Exhibit A-23**.

39. The Division entered Order No. R-23990 in Case No. 25358 on September 8, 2025. Following the issuance of the Order, Riley by physical mail and email a copy of the Order to an XTO landman. Email String between Mark Smith and Chad Smith (09/26/2025), attached as **Exhibit A-24**.⁴

40. As with the Eagle wells, XTO requested that it be permitted to participate in the development instead of being treated as a pooled party because it had never received notice of the hearing. Riley denied XTO's request on the grounds that the time to voluntarily participate had lapsed.

XTO's Address

41. For each of the applications identified above, the certified mail receipts indicate that notice was sent to XTO at P.O. Box 840780, Dallas, TX 75284. However, that is not XTO's mailing address. Rather, XTO's mailing address is 22777 Springwoods Village Parkway, Spring, TX 77389—information that can be gleaned from a simple internet search or from the email signatures of XTO employees with whom Riley frequently communicated. *See* Printout from Internet Search, attached as **Exhibit A-25**; *see also* Email from Chad Smith to Mark Smith (Mar. 14, 2024), attached as **Exhibit A-26**.

42. The Dallas address is a separate post office box for the submission of joint interest billing (“JIB”) checks. It is shared by multiple companies and is not a mailing address for XTO.

43. Despite this, Riley sent the notices in all four matters to the wrong address. XTO received no other communication from Riley notifying XTO of the hearings, despite Riley having a working e-mail address for an XTO landman.

44. The attached exhibits were either prepared by me or under my supervision or were compiled from company business records.

45. I understand this Self-Affirmed Statement will be used as written testimony in this case. I affirm that my testimony above is true and correct and it made under penalty of perjury under the laws of the State of New Mexico. My testimony is made as of the date next to my signature below.

APPLICATION

Riley Permian Operating Company, LLC, OGRID No. 372290 (“Riley” or “Applicant”), through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, § 70-2-17 and 19.15.16.15(B)(5) NMAC, for an order (1) approving a 160-acre, more or less, non-standard horizontal spacing unit (“HSU”) composed of the N/2 S/2 of Section 33, Township 17 South, Range 27 East, N.M.P.M. (the “Application Lands”), and (2) pooling all uncommitted mineral interests in the Yeso Formation, designated as an oil pool, underlying said HSU.

In support of its Application, Riley states the following:

1. Riley is a working interest owner in the Application Lands and has a right to drill wells thereon as the designated Operator of the Application Lands.
2. Riley seeks to dedicate all of the Application Lands to form a 160-acre, more or less, HSU.
3. Riley seeks to dedicate the above-referenced HSU to the following proposed wells:
 - A. **Eagle 33 Fed Com #004H** (API No. 30-015-49329), which is an oil well that will be horizontally drilled from a surface location in the NW/4SW/4 (Unit L) of

Section 34, Township 17 South, Range 27 East, to a bottom hole location in the Yesso Formation in Lot 12 (Unit L) of Section 33, Township 17 South, Range 27 East;

B. **Eagle 33 Fed Com #005H** (API No. 30-015-49711), which is an oil well that will be horizontally drilled from a surface location in the NW/4SW/4 (Unit L) of Section 34, Township 17 South, Range 27 East, to a bottom hole location in the Yesso Formation in Lot 12 (Unit L) of Section 33, Township 17 South, Range 27 East;

4. The wells are orthodox in their location as defined by 19.15.16.15.(C) NMAC, and the take points and laterals comply with Statewide Rules for setbacks under 19.15.16.15.(C) NMAC.

5. Riley has sought in good faith but has been unable to obtain voluntary agreement from all interest owners in the Yesso Formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.

6. The pooling of all interests in the Yesso Formation within the proposed unit will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

7. Approval of a non-standard horizontal spacing unit is necessary to prevent waste and protect correlative rights.

8. To provide for its just and fair share of the oil and gas underlying the subject lands, Riley requests that all uncommitted interests in this HSU be pooled and that Riley be designated as the operator of the proposed horizontal wells and HSU.

WHEREFORE, Riley requests this Application be set for hearing on January 9th, 2025, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

- A. Approving the creation of an approximately 160-acre non-standard HSU, composed of the Application Lands, pursuant to 19.15.16.15(B)(5) NMAC;
- B. Pooling all uncommitted interests in the Yeso Formation underlying the HSU within the Application Lands;
- C. Approving the **Eagle 33 Fed Com #004H** and **Eagle 33 Fed Com #005H** as the wells for the HSU.
- D. Designating Riley as operator of the HSU and the horizontal wells to be drilled thereon;

1. **Election & Tender.** On April 4, 2025, XTO Holdings, LLC elected to participate based on Estimated Well Costs emailed by Riley Permian Operating Company, LLC. Enclosed are six check requests in the amount of \$2,331,730 for each well representing XTO Holdings, LLC 50% WI share of Estimated Well Costs for the Eagle 33 Federal Com 4H, Eagle 33 Federal Com 5H, Eagle 33 Federal Com 7H, Eagle 33 Federal Com 8H, Eagle 33 Federal Com 10H, Eagle 33 Federal Com 11H, together with any outstanding JIB items provided to date. This tender is without prejudice and subject to OCD clarification of deadlines.
2. **Service Defects.** Riley Permian Operating Company, LLC, did not serve XTO Holdings, LLC or provide it proper notice with the pooling hearing notice by certified mail to its last-known address, nor serve the final order by certified mail, as expressly required under New Mexico law. See NMSA 1978, § 70-2-17 (notice and hearing), and 19.15.4.12 NMAC (service by certified mail; publication after diligent search). Because proper service never occurred, the election and payment clocks in ¶27 of the Order did not commence as to XTO Holdings, LLC. Moreover, the failure of notice invalidates the Order in its entirety and XTO Holdings, LLC reserves its rights to Motion the OCD to re-open the hearing and assert an objection to the voidable Order.

3. **Requested Cure.** To avoid motion practice, XTO Holdings, LLC requests that Riley Permian Operating Company, LLC (a) re-serve the Order and Estimated Well Costs by certified mail, (b) confirm in writing that XTO Holdings, LLC is recognized as a consenting working interest owner, and (c) reset XTO Holdings, LLC's election/payment deadlines to run from proper service. XTO Holdings, LLC remains ready to fund and cooperate immediately. If agreed, then XTO Holdings, LLC will waive its rights to object to the improper Order subject to it being allowed to being considered a consenting working interest owner under the existing Order.

If we do not receive written confirmation within **[5 business days]**, XTO Holdings, LLC will file a targeted motion to reopen/vacate the Order with the NMOCD.

Riley Permian Operating Company, LLC ("Riley") writes to respond to your letter dated November 19, 2025 (the "Letter"), in reference to certain notices and elections under the OCD approved Compulsory Pooling Orders R-23729, R-23730 and R-23731 (the "Orders").

1. On April 4, 2025, XTO Holdings, LLC ("XTO") elected to participate in the Eagle 33 Federal Com 4H, 5H, 7H, 8H, 10H and 11H wells. Riley acknowledged XTO's election to participate. Riley has never disputed the validity of XTO's election to participate. However, XTO failed to make a timely payment per paragraph 27 of the Orders.
2. Riley provided proper notice to XTO via certified mail on 10/30/2024 and 3/6/2025 and provided such proof to XTO via email on March 19, 2025. Riley used the same address it has on file for XTO in its current JIB/REV decks for other wells/properties in New Mexico. Upon providing XTO the proof of delivery in the email described above, Riley was given another address to use for XTO and Riley has updated its records accordingly. Riley subsequently emailed the proposals to XTO once more on March 24, 2025, and XTO confirmed receipt of the proposals via email dated March 24, 2025.
3. Per the OCD regulations, only party(s) or their attorney of record are sent Orders after they are issued. Orders are sent by the OCD, not the operator/applicant, nor their attorney. For copies of commission and division orders, the OCD defines the "parties to a case" as the "applicant and each person who has entered an appearance in the case—in person or by attorney—by filing a protest, pleading, or notice of appearance." 19.15.4.24 NMAC. XTO did not enter an appearance in any of the OCD Cases pertaining to the Orders. Neither Riley nor its attorney are required to send the Orders directly to XTO as alluded to in the Letter.

Riley Permian Operating Company, LLC, OGRID No. 372290 (“Riley” or “Applicant”), through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, § 70-2-17 and 19.15.16.15(B)(5) NMAC, for an order (1) approving a 160-acre, more or less, non-standard horizontal spacing unit (“HSU”) composed of the S/2 N/2 of Section 33, Township 17 South, Range 27 East, N.M.P.M. (the “Application Lands”), and (2) pooling all uncommitted mineral interests in the Yeso Formation, designated as an oil pool, underlying said HSU. ”), and (2) pooling all uncommitted mineral interests in the Yeso Formation, designated as an oil pool, underlying said HSU.

In support of its Application, Riley states the following:

1. Riley is a working interest owner in the Application Lands and has a right to drill wells thereon as the designated Operator of the Application Lands.
2. Riley seeks to dedicate all of the Application Lands to form a 160-acre, more or less, HSU.
3. Riley seeks to dedicate the above-referenced HSU to the following proposed wells:
 - A. **Eagle 33 Fed Com #007H** (API No. 30-015-49713), which is an oil well that will be horizontally drilled from a surface location in the SW/4NW/4 (Unit E) of

Section 34, Township 17 South, Range 27 East, to a bottom hole location in the Yeso Formation in Lot 5 (Unit E) of Section 33, Township 17 South, Range 27 East;

B. **Eagle 33 Fed Com #008H** (API No. 30-015-49714), which is an oil well that will be horizontally drilled from a surface location in the SW/4NW/4 (Unit E) of Section 34, Township 17 South, Range 27 East, to a bottom hole location in the Yeso Formation in Lot 5 (Unit E) of Section 33, Township 17 South, Range 27 East;

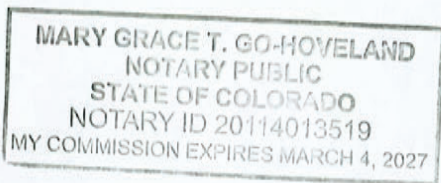

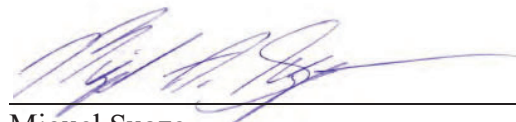

In support of its Application, Riley states the following:

3. Riley seeks to dedicate the above-referenced HSU to the following proposed wells:
 - A. **Eagle 33 Fed Com #010H** (API No. 30-015-49668) which is an oil well that will be horizontally drilled from a surface location in the NW/4NW/4 (Unit D) of

Section 34, Township 17 South, Range 27 East, to a bottom hole location in the Yeso Formation in Lot 4 (Unit D) of Section 33, Township 17 South, Range 27 East;

B. **Eagle 33 Fed Com #011H** (API No. 30-015-49475), which is an oil well that will be horizontally drilled from a surface location in the NW/4NW/4 (Unit D) of Section 34, Township 17 South, Range 27 East, to a bottom hole location in the Yeso Formation in Lot 4 (Unit D) of Section 33, Township 17 South, Range 27 East;

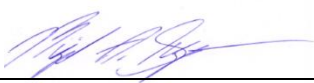

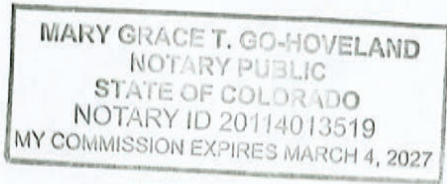

Riley Permian Operating, LLC, OGRID No. 372290 (“Riley” or “Applicant”), through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, § 70-2-17, for an order (1) approving a 481.47-acre, more or less, standard horizontal spacing unit (“HSU”) composed of the N/2 of Section 12, Township 18 South, Range 26 East, N.M.P.M., and the NW/4 of Section 7, Township 18 South, Range 27 East, N.M.P.M. (the “Application Lands”), and (2) pooling all uncommitted mineral interests in the Yeso Pool (51120), designated as an oil pool, underlying said HSU.

In support of its Application, Riley states the following:

1. Riley and/or its affiliates are working interest owners in the Application Lands and have the right to drill wells thereon as the designated Operator of the Application Lands.
2. Riley seeks to dedicate all of the Application Lands to form a 481.47-acre, more or less, HSU.
3. Riley seeks to dedicate the above-referenced HSU to the following proposed wells:
 - A. **Marty Fee 11-7 1H** (API No. *Pending*), which is an oil well that will be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 11, Township 18 South, Range 26 East, to a bottom hole location in the Yeso Pool in the NE/4 NW/4 (Unit C) of Section 7, Township 18 South, Range 27 East;

B. **Marty Fee 11-7 2H** (API No. *Pending*), which is an oil well that will be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 11, Township 18 South, Range 26 East, to a bottom hole location in the Yeso Pool in the NE/4 NW/4 (Unit C) of Section 7, Township 18 South, Range 27 East;

C. **Marty Fee 11-7 3H** (API No. *Pending*), which is an oil well that will be horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 11, Township 18 South, Range 26 East, to a bottom hole location in the Yeso Pool in the SE/4 NW/4 (Unit F) of Section 7, Township 18 South, Range 27 East, and;

D. **Marty Fee 11-7 4H** (API No. *Pending*), which is an oil well that will be horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 11, Township 18 South, Range 26 East, to a bottom hole location in the Yeso Pool in the SE/4 NW/4 (Unit F) of Section 7, Township 18 South, Range 27 East.

4. The wells are orthodox in their location as defined by 19.15.16.15.(C) NMAC, and the take points and laterals comply with Statewide Rules for setbacks under 19.15.16.15.(C) NMAC.

5. Riley has made good faith efforts to obtain voluntary agreement from all interest owners in the Yeso Pool underlying the proposed spacing unit, but has been unable to secure agreement from all parties to participate in the drilling of the well or otherwise commit their interests.

6. The pooling of all interests in the Yeso Pool within the proposed unit will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

7. To provide for its just and fair share of the oil and gas underlying the Application Lands, Riley requests that all uncommitted interests in this HSU be pooled and that Riley be designated as the operator of the proposed horizontal wells and HSU.

WHEREFORE, Riley requests this Application be set for hearing on May 8, 2025, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

- A. Approving the horizontal well spacing unit and pooling all uncommitted interests in the Yeso Pool underlying the HSU within the Application Lands;
- B. Approving the **Marty Fee 11-7 1H, Marty Fee 11-7 2H, Marty Fee 11-7 3H, and Marty Fee 11-7 4H** as the initial wells for the HSU;
- C. Designating Riley as operator of the HSU and the horizontal wells to be drilled thereon;
- D. Authorizing Riley to recover its costs of drilling, completing, and equipping the wells;
- E. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% charge for the risk assumed by Riley in drilling and completing the wells against any working interest owner who does not voluntarily participate in the drilling of the wells.
