**APPLICATION OF XTO HOLDINGS, LLC
TO REOPEN LONGFELLOW ENERGY, L.P.
CASE NO. 25903, EDDY COUNTY, NEW MEXICO.**

APPLICATION

XTO Holdings, LLC (“XTO”), through its undersigned counsel, files this Application to Re-Open Longfellow Energy, L.P. (“Longfellow”) Case No. 25903, in which the Oil Conservation Division (“Division”) issued Order No. R-24217. In support of its Application, XTO states the following.

1. Longfellow filed its application in Case No. 25903 on January 6, 2026.
2. On February 5, 2026, Longfellow presented Case No. 25903 by affidavit to the Division.
3. At the hearing, Longfellow indicated that it sought to pool the following parties:
 - a. SEP Permian Holding Corp.;
 - b. JR Oil, Ltd.;
 - c. BP America Production Company;
 - d. Apache Corporation;
 - e. Hilcorp Energy 1, L.P.;
 - f. OXY USA WTP Limited Partnership;
 - g. R.L. Tayloe-Richard Lee Tayloe, Jr. Trust Estate, Bank of America, NA, Trustee;
 - h. Peggy Runyan;

- i. Moser Revocable Trust, Charles E. Moser and Vicky J. Moser and their successors, as Trustee, Under Trust Agreement dated December 21, 1989; and
- j. Fullerton Oil & Gas Corporation.

4. During the hearing, the Division admitted Longfellow's exhibits into the record, including Exhibit A-2, which identifies Exxon Mobil as the Lessee of Record for Lease NMLC 0056302B – the E/2 NE/4 of Section 33, Township 16 South, Range 31 East, Eddy County. *See* Longfellow Exhibit A-2.

5. Longfellow's exhibits also includes Exhibit C, an Affirmation of Notice from Longfellow's counsel. Exhibit C-2 identifies all parties who received notice of the hearing. *See* Longfellow Exhibit C-2. Neither XTO nor ExxonMobil is listed on Exhibit C-2.

6. The Division entered Order No. R-24217 ("Order") in Case No. 25903 on February 13, 2026.

7. The Order pooled uncommitted interests in the Yeso formation underlying a 320 acre, more or less, standard horizontal spacing unit comprised of the N/2 of Section 33, Township 16 South, Range 31 East, in Eddy County, New Mexico ("Subject Lands"), and dedicated the unit to the Van Halen 33AB Fed Com 001H, Van Halen 33AB Fed Com 002H, Van Halen 33AB Fed Com 003H, Van Halen 33AB Fed Com 004H, Van Halen 33AB Fed Com 005H, Van Halen 33AB Fed Com 006H, Van Halen 33AB Fed Com 007H, and Van Halen 33AB Fed Com 008H wells. The Order further designated Longfellow as operator of the Subject Lands.

8. As set out in sworn testimony filed by Longfellow in Case No. 25804, Longfellow has been negotiating with XTO regarding Lease NMLC 0056302B, which is the same lease involved in Case No. 25903, since October 2025. *See* Longfellow Exhibits Case No. 25804 at pp. 21-26 of 136 (filed 2/20/26).

9. Longfellow's testimony in Case No. 25804 admits that XTO has a working interest in the acreage involved in Case No. 25803. *See id.* at p. 25 of 136.

10. Pursuant to 19.15.4.12 NMAC, Longfellow was obligated to send notice to each owner of an uncommitted interest in the mineral estate of the lands the applicant proposes to be pooled whose interest is evidenced by a written conveyance document either of record or known to the applicant. Despite working with XTO on acreage covered by the same lease and admitting that XTO has a working interest in the Subject Lands, Longfellow failed to provide notice to XTO and failed to identify XTO as a working interest owner.

11. Longfellow was required to provide proper notice of the pooling application and hearing to XTO but failed to do so.

WHEREFORE, XTO respectfully requests that the Division set this matter for hearing on March 26, 2026, reopen the case to remedy Longfellow's failure of notice, and provide XTO with the opportunity to exercise its right to participate in Longfellow's development.
