**APPLICATION OF MEWBOURNE OIL  
COMPANY FOR COMPULSORY POOLING,  
EDDY COUNTY, NEW MEXICO**

**APPLICATION**

Pursuant to NMSA § 70-2-17, Mewbourne Oil Company, (OGRID No. 14744) (“Applicant”) applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 546.43-acre, more or less, standard horizontal spacing unit comprised of Lots 17–24 of irregular Section 3, and Lots 2, 7, 8, and 17–21 of irregular Section 4, Township 21 South, Range 26 East, Eddy County, New Mexico (“Unit”). In support of its application, Mewbourne states the following.

1. Applicant is a working interest owner in the Unit and has the right to drill wells thereon.
2. The Unit will be dedicated to the **King Harvest 3/4 Fed Com #522H** and **King Harvest 3/4 Fed Com #622H** wells (“Wells”), which will be drilled from a surface hole location in Lot 21 of irregular Section 2 to a bottom hole location in Lot 20 of irregular Section 4.
3. The completed intervals of the Wells will be orthodox.
4. The completed interval of the **King Harvest 3/4 Fed Com #522H** well will be located within 330’ of the line separating Lots 17–20 from Lots 24–21 of irregular Section 3 and the line separating Lots 17–19 and 2 from Lots 7, 8 and 20–21 of irregular Section 4 to allow for the creation of a 546.43-acre standard horizontal spacing unit.

5. Applicant has undertaken diligent, good faith efforts to obtain voluntary agreements from all interest owners to participate in the drilling of the Wells but has been unable to obtain voluntary agreements from all interest owners.

6. The pooling of uncommitted interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

7. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in the Unit should be pooled and Applicant should be designated the operator of the Wells and the Unit.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on May 7, 2026, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the Wells in the Unit;
- C. Designating Applicant as operator of the Unit and the Wells to be drilled thereon;
- D. Authorizing Applicant to recover its costs of drilling, equipping and completing the Wells;
- E. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% penalty for the risk assumed by Applicant in drilling and completing the Wells against any working interest owner who does not voluntarily participate in the drilling of the Wells.
