**APPLICATION**

MRC Permian Company (“MRC” or “Applicant”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to extend the drilling deadline under compulsory pooling Order No. R-23878 (“Pooling Order”). In support of its application, MRC states:

1. On July 24, 2025, the Division entered Order No. R-23878 in Case No. 25388, which pooled the uncommitted interests underlying a standard 480-acre, more or less, horizontal well spacing unit in the Pennsylvanian formation (Dean; Permo Upper Penn [16720]) comprised of the W/2 W/2 of Sections 11, 14, and 23, Township 15 South, Range 36 East, NMPM, Lea County, New Mexico (the “Unit”). Matador Production Company (OGRID No. 228937) is the operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Ed Drake Federal Com 241H** (API No. 30-025-PENDING) well.

2. This is MRC’s first request to extend the deadline to commence drilling the initial well under the Pooling Order. MRC is simultaneously seeking an extension through the Division’s request for deviation process, per paragraph 21 of the Pooling Order, and will dismiss this case if approved.

3. Under the Order, Applicant would be required to commence drilling the well by July 25, 2026, and therefore, asks for the deadline to commence drilling the well be extended for a year, to July 25, 2027.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on June 4, 2026, and, after notice and hearing as required by law, the Division enter an order extending the time for MRC to commence drilling the proposed initial well under the Order.

**CASE \_\_\_\_\_:**     **Application of MRC Permian Company to Extend the Drilling Deadline Under Order No. R-23878, Lea County, New Mexico.** Applicant in the above-styled cause seeks a year extension of time for drilling the initial well under Order No. R-23878. The Unit is a standard 480-acre, more or less, horizontal well spacing unit in the Pennsylvanian formation (Dean; Permo Upper Penn [16720]) comprised of the W/2 W/2 of Sections 11, 14, and 23, Township 15 South, Range 36 East, NMPM, Lea County, New Mexico. Order No. R-23878 pooled the uncommitted mineral interests in the Pennsylvanian formation and dedicated the Unit to the proposed **Ed Drake Federal Com 241H** (API No. 30-025-PENDING) well, to be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 23, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 11. The subject area is located approximately 6.5 miles northeast of Lovington, New Mexico.
