STATEMENT OF THE CASES

In **Case No. 26230**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 400.7788-acre, more or less, standard horizontal spacing unit comprised of the N/2 NE/4 of Section 9, and the N/2 N/2 of Sections 10 and 11, Township 22 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the **Buffalo Thunder 9/11 Fed Com #521H (B2BA)** well, which will be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 9 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 11.

In **Case No. 26231**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 400.7788-acre, more or less, standard horizontal spacing unit comprised of the S/2 NE/4 of Section 9, and the S/2 N/2 of Sections 10 and 11, Township 22 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the **Buffalo Thunder 9/11 Fed Com #523H (B2GH)** well, which will be drilled from a surface hole location in the SW/4 NE/4 (Unit G) of Section 9, to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 11.

In **Case No. 26232**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying an 801.5576-acre, more or less, standard horizontal spacing unit comprised of the NE/4 of Section 9, and the N/2 of Sections 10 and 11, Township 22 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the following wells: **Buffalo Thunder 9/11 Fed Com #711H (W0BA)** and **Buffalo Thunder 9/11 Fed Com #821H (W2BA)**, which will be drilled from surface hole locations in the SW/4 NE/4 (Unit G) of Section 9 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 11; and **Buffalo Thunder 9/11 Fed Com #714H (W0GH)** and **Buffalo Thunder 9/11 Fed Com #823H (W2GH)**, which will be drilled from surface hole locations in the SW/4 NE/4 (Unit G) of Section 9 to a bottom hole locations in the SE/4 NE/4 (Unit H) of Section 11.

The completed intervals of the Buffalo Thunder Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as the operator of the units and sells, and a 200% charge for the risk involved in drilling and completing the wells.
