APPLICATION

Catamount Energy Partners LLC (“Catamount” or “Applicant”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to (1) extend the drilling deadline under compulsory pooling Order No. R-23613, as amended, and (2) add an additional initial well to the Pooling Order. In support of its application, Catamount states:

1. On December 24, 2024, the Division entered Order No. R-23613 in Case No. 24830, which approved a non-standard 1,941.18-acre, more or less, horizontal spacing unit in the Mancos formation (Basin Mancos (Gas) [97232]) comprised of Lots 1-4, S/2 N/2 and SE/4 (All equivalent) of irregular Section 9, Lots 1-4, S/2 N/2 and S/2 (All equivalent) of irregular Sections 10 and 11, and Lots 1-4, S/2 N/2, SW/4 and NW/4 SE/4 of irregular Section 12, Township 32 North, Range 6 West, NMPM, San Juan and Rio Arriba Counties, New Mexico (the “Unit”), and pooled the uncommitted interests therein. Catamount is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Miller Mesa 32-6-10 1H** (API No. Pending), **Miller Mesa 32-6-11 1H** (API No. Pending), and **NLN 32-6-9 2H** (API No. 30-045-38534).

2. On January 19, 2026, the Division issued Order No. R-23613-A in Case No. 25765 extending the period to drill the wells until December 24, 2026.

3. Good cause exists to extend the deadline to commence drilling the initial wells under the Pooling Order.

4. Under the Order, Applicant would be required to commence drilling the wells by December 24, 2026, and therefore, asks for the deadline to commence drilling the wells be extended for a year, to December 24, 2027.

5. Catamount further requests to amend the Pooling Order and add the **NLN 32-6-9 1H** (API No. Pending) to the Pooling Order as an initial well.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 9, 2026, and, after notice and hearing as required by law, the Division enter an order extending the time for Catamount to commence drilling the proposed initial wells under the Order and add the requested additional initial well to the Pooling Order.

CASE _____: **Application of Catamount Energy Partners LLC to Extend the Drilling Deadline And Add An Additional Initial Well Under Order No. R-23613, As Amended, San Juan and Rio Arriba Counties, New Mexico.** Applicant in the above-styled cause seeks a year extension of time for drilling the wells under Order No. R-23613, as amended, and to add an additional initial well under the Pooling Order. The Unit is a non-standard 1,941.18-acre, more or less, horizontal spacing unit in the Mancos formation (Basin Mancos (Gas) [97232]) comprised of Lots 1-4, S/2 N/2 and SE/4 (All equivalent) of irregular Section 9, Lots 1-4, S/2 N/2 and S/2 (All equivalent) of irregular Sections 10 and 11, and Lots 1-4, S/2 N/2, SW/4 and NW/4 SE/4 of irregular Section 12, Township 32 North, Range 6 West, NMPM, San Juan and Rio Arriba Counties, New Mexico. Order No. R-23613 approved the non-standard spacing unit and pooled the uncommitted interests in the Mancos formation and dedicated the Unit to the proposed initial **Miller Mesa 32-6-10 1H** well, to be horizontally drilled from a surface hole location in the SW/4 NE/4 (Unit G) of irregular Section 10, to a bottom hole location SW/4 NW/4 (Unit E) of irregular Section 9; **Miller Mesa 32-6-11 1H** well, to be horizontally drilled from a surface hole location in the SW/4 NE/4 (Unit G) of irregular Section 10, to a bottom hole location in the SE/4 NE/4 (Unit H) of irregular Section 12; and **NLN 32-6-9 2H** well, to be horizontally drilled from a surface hole location in the NW/4 SW/4 (Unit L) of irregular Section 9, to a bottom hole location in the NW/4 SE/4 (Unit J) of irregular Section 12. Catamount seeks to add the **NLN 32-6-9 1H** to the Pooling Order. Said area is located approximately 3 miles southeast of Young Place, New Mexico.

ORDER

The Director of the New Mexico Oil Conservation Division (“OCD”), having heard this matter through a Hearing Examiner on October 10, 2024, and after considering the testimony, evidence, and recommendation of the Hearing and Technical Examiners, issues the following Order.

FINDINGS OF FACT

1. Catamount Energy Partners, LLC (“Operator”) submitted an application (“Application”) to compulsory pool the uncommitted oil and gas interests within the spacing unit (“Unit”) described in Exhibit A. Operator seeks to be designated the operator of the Unit.
2. Operator will dedicate the well(s) described in Exhibit A (“Well(s)”) to the Unit.
3. Operator proposes the supervision and risk charges for the Well(s) described in Exhibit A.
4. Operator identified the owners of uncommitted interests in oil and gas minerals in the Unit and provided evidence that notice was given.
5. The Application was heard by the Hearing Examiner on the date specified above, during which Operator presented evidence through affidavits in support of the Application. No other party presented evidence at the hearing.

CONCLUSIONS OF LAW

6. OCD has jurisdiction to issue this Order pursuant to NMSA 1978, Section 70-2-17.
7. Operator is the owner of an oil and gas working interest within the Unit.
8. Operator satisfied the notice requirements for the Application and the hearing as required by 19.15.4.12 NMAC.
9. OCD satisfied the notice requirements for the hearing as required by 19.15.4.9 NMAC.
10. Operator has the right to drill the Well(s) to a common source of supply at the

depth(s) and location(s) in the Unit described in Exhibit A.

11. The Unit contains separately owned uncommitted interests in oil and gas minerals.
12. Some of the owners of the uncommitted interests have not agreed to commit their interests to the Unit.
13. The pooling of uncommitted interests in the Unit will prevent waste and protect correlative rights, including the drilling of unnecessary wells.
14. This Order affords to the owner of an uncommitted interest the opportunity to produce his just and equitable share of the oil or gas in the pool.

ORDER

15. The Unit is approved as a non-standard horizontal spacing unit.
16. Operator shall file Forms C-102 reflecting the correct acreage dedicated for each of the Wells.
17. The uncommitted interests in the Unit are pooled as set forth in Exhibit A.
18. The Unit shall be dedicated to the Well(s) set forth in Exhibit A.
19. Operator is designated as operator of the Unit and the Well(s).
20. If the location of a well will be unorthodox under the spacing rules in effect at the time of completion, Operator shall obtain the OCD's approval for a non-standard location in accordance with 19.15.16.15(C) NMAC.
21. If the Unit is a non-standard horizontal spacing unit which has not been approved under this Order, Operator shall obtain the OCD's approval for a non-standard horizontal spacing unit in accordance with 19.15.16.15(B)(5) NMAC.
22. The Operator shall commence drilling the Well(s) within one year after the date of this Order, and complete each Well no later than one (1) year after the commencement of drilling the Well.
23. This Order shall terminate automatically if the Operator fails to comply with the preceding paragraph unless the Operator requests an extension by notifying the OCD and all parties that required notice of the original compulsory pooling application in accordance with 19.15.4.12.B and 19.15.4.12.C NMAC. Upon no objection after twenty (20) days the extension is automatically granted up to one year. If a protest is received the extension is not granted and the Operator must set the case for a hearing.

24. Operator may propose reasonable deviations from the development plan via notice to the OCD and all parties that required notice of the original compulsory pooling application in accordance with 19.15.4.12.B and 19.15.4.12.C NMAC. Upon no objection after twenty (20) days the deviation is automatically granted. If a protest is received the deviation is not granted and the Operator must set the case for a hearing.
25. The infill well requirements in 19.15.13.9 NMAC through 19.15.13.12 NMAC shall be applicable.
26. Operator shall submit each owner of an uncommitted working interest in the pool ("Pooled Working Interest") an itemized schedule of estimated costs to drill, complete, and equip the well ("Estimated Well Costs").
27. No later than thirty (30) days after Operator submits the Estimated Well Costs, the owner of a Pooled Working Interest shall elect whether to pay its share of the Estimated Well Costs or its share of the actual costs to drill, complete and equip the well ("Actual Well Costs") out of production from the well. An owner of a Pooled Working Interest who elects to pay its share of the Estimated Well Costs shall render payment to Operator no later than thirty (30) days after the expiration of the election period, and shall be liable for operating costs, but not risk charges, for the well. An owner of a Pooled Working Interest who fails to pay its share of the Estimated Well Costs or who elects to pay its share of the Actual Well Costs out of production from the well shall be considered to be a "Non-Consenting Pooled Working Interest."
28. No later than one hundred eighty (180) days after Operator submits a Form C-105 for a well, Operator shall submit to each owner of a Pooled Working Interest an itemized schedule of the Actual Well Costs. The Actual Well Costs shall be considered to be the Reasonable Well Costs unless an owner of a Pooled Working Interest files a written objection no later than forty-five (45) days after receipt of the schedule. If an owner of a Pooled Working Interest files a timely written objection, OCD shall determine the Reasonable Well Costs after public notice and hearing.
29. No later than sixty (60) days after the expiration of the period to file a written objection to the Actual Well Costs or OCD's order determining the Reasonable Well Costs, whichever is later, each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs shall pay to Operator its share of the Reasonable Well Costs that exceed the Estimated Well Costs, or Operator shall pay to each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs its share of the Estimated Well Costs that exceed the Reasonable Well Costs.
30. The reasonable charges for supervision to drill and produce a well ("Supervision Charges") shall not exceed the rates specified in Exhibit A, provided however that

the rates shall be adjusted annually pursuant to the COPAS form entitled "Accounting Procedure-Joint Operations."

31. No later than within ninety (90) days after Operator submits a Form C-105 for a well, Operator shall submit to each owner of a Pooled Working Interest an itemized schedule of the reasonable charges for operating and maintaining the well ("Operating Charges"), provided however that Operating Charges shall not include the Reasonable Well Costs or Supervision Charges. The Operating Charges shall be considered final unless an owner of a Pooled Working Interest files a written objection no later than forty-five (45) days after receipt of the schedule. If an owner of a Pooled Working Interest files a timely written objection, OCD shall determine the Operating Charges after public notice and hearing.
32. Operator may withhold the following costs and charges from the share of production due to each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs: (a) the proportionate share of the Supervision Charges; and (b) the proportionate share of the Operating Charges.
33. Operator may withhold the following costs and charges from the share of production due to each owner of a Non-Consenting Pooled Working Interest: (a) the proportionate share of the Reasonable Well Costs; (b) the proportionate share of the Supervision and Operating Charges; and (c) the percentage of the Reasonable Well Costs specified as the charge for risk described in Exhibit A.
34. Operator shall distribute a proportionate share of the costs and charges withheld pursuant to the preceding paragraph to each Pooled Working Interest that paid its share of the Estimated Well Costs.
35. Each year on the anniversary of this Order, and no later than ninety (90) days after each payout, Operator shall provide to each owner of a Non-Consenting Pooled Working Interest a schedule of the revenue attributable to a well and the Supervision and Operating Costs charged against that revenue.
36. Any cost or charge that is paid out of production shall be withheld only from the share due to an owner of a Pooled Working Interest. No cost or charge shall be withheld from the share due to an owner of a royalty interests. For the purpose of this Order, an unleased mineral interest shall consist of a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest.
37. Except as provided above, Operator shall hold the revenue attributable to a well that is not disbursed for any reason for the account of the person(s) entitled to the revenue as provided in the Oil and Gas Proceeds Payment Act, NMSA 1978, Sections 70-10-1 *et seq.*, and relinquish such revenue as provided in the Uniform Unclaimed Property Act, NMSA 1978, Sections 7-8A-1 *et seq.*
38. The Unit shall terminate if (a) the owners of all Pooled Working Interests reach a voluntary agreement; or (b) the well(s) drilled on the Unit are plugged and

abandoned in accordance with the applicable rules. Operator shall inform OCD no later than thirty (30) days after such occurrence.

39. OCD retains jurisdiction of this matter for the entry of such orders as may be deemed necessary.

1. My name is Denise Greer. I work for Catamount Energy Partners LLC (“Catamount”) as a Senior Landman.

2. I have previously testified before the New Mexico Oil Conservation Division (“Division”) as an expert witness in petroleum land matters. My credentials as a petroleum landman have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by Catamount in this case, and I am familiar with the status of the lands in the subject area.

4. None of the uncommitted parties in this case have indicated opposition to proceeding by self-affirmed statement and, therefore, I do not expect any opposition at the hearing.

5. On December 24, 2024, the Division entered Order No. R-23613 (“Pooling Order”) in Case No. 24830, which approved a non-standard 1,941.18-acre, more or less, horizontal spacing unit in the Mancos formation (Basin Mancos (Gas) [97232]) comprised of Lots 1-4, S/2 N/2 and SE/4 (All equivalent) of irregular Section 9, Lots 1-4, S/2 N/2 and S/2 (All equivalent) of irregular Sections 10 and 11, and Lots 1-4, S/2 N/2, SW/4 and NW/4 SE/4 of irregular Section 12, Township 32 North, Range 6 West, NMPM, San Juan and Rio Arriba Counties, New Mexico (the “Unit”), and pooled the uncommitted interests therein. Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Miller Mesa 32-6-10 1H** (API No. Pending), **Miller Mesa 32-6-11 1H** (API No. Pending), and **NLN 32-6-9 2H** (API No. 30-045-38534).

6. Catamount requests to amend the Pooling Order and add the **NLN 32-6-9 1H** (API No. Pending) to the Pooling Order as an initial well.

7. The attached **Catamount Exhibit D-1** contains a draft Form C-102 for the additional proposed well. The exhibit shows that the well will be assigned to the Basin Mancos (Gas) [97232].

8. **Catamount Exhibit D-2** is an updated pooling exhibit that identifies the parties that remain subject to the Pooling Order.

9. **Catamount Exhibit D-3** contains a sample of the well proposal letter and AFEs sent to owners with a working interest for the additional initial well. The costs reflected in the AFEs are consistent with what Catamount and other operators have incurred for drilling similar horizontal wells in the area in this formation.

10. Catamount requests that the overhead and administrative costs for drilling and producing the proposed well be set at \$12,000 per month while drilling and \$1,200 per month while producing. These costs are consistent with what other operators are charging in this area for similar wells.

11. **Catamount Exhibit D-4** contains a general summary of the contacts with the uncommitted interest owners with regard to the additional initial well to be included under the Pooling Order. As indicated in the exhibit, Catamount has made a good faith effort to locate and has had communications with all of the parties that it seeks to pool in this case in an effort to reach

voluntary joinder. In my opinion, Catamount has undertaken good faith efforts to reach an agreement with the uncommitted interest owners.

12. Catamount has provided the law firm of Holland & Hart LLP with the names and addresses of the parties subject to the existing pooling order and instructed that they be notified of Catamount's application. In compiling this notice list, Catamount conducted a diligent search of all public records in the county where the proposed wells are located, including computer searches.

13. Additionally, there is good cause for a second extension. There have been significant delays in securing water sourcing for drilling and completions. Currently, Catamount has a lease on water in the Navajo Reservoir; however, Catamount is still working on permitting a location for the physical pump on the lake shore and obtaining a Right of Way ("ROW") from the United States Bureau of Reclamation for the pipe to transport the water, and neither has been approved yet. Once approved, timing restrictions will apply and Catamount will not be able to use the pump site between December 1 through March 30.

14. The granting of this application will prevent waste and protect correlative rights.

15. **Catamount Exhibits D-1 through D-4** were either prepared by me or compiled under my direction and supervision.

16. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.
