STATEMENT OF THE CASES

In **Case No. 26219**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 23 and 24, Township 22 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the following wells: **El Duderino 23/24 Fed Com #523H (B2EH)** well, which will be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 23 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 24; and **El Duderino 23/24 Fed Com #521H (B2DA)** and **El Duderino 23/24 Fed Com #552H (H3DA)** wells, which will be drilled from surface hole locations in the NW/4 SW/4 (Unit L) of Section 23 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 24.

The completed interval of the El Duderino 23/24 Fed Com #552H (H3DA) well will be located within 330' of the quarter-quarter section line separating the N/2 N/2 and S/2 N/2 of Sections 23 and 24 to allow for the creation of a 640-acre standard horizontal spacing unit.

In **Case No. 26220**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 1,280-acre, more or less, standard horizontal spacing unit comprised of all of Sections 23 and 24, Township 22 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the following wells: **El Duderino 23/24 Fed Com #713H (W0EH)** and **El Duderino 23/24 Fed Com #824H (W2EH)** wells, which will be drilled from surface hole locations in the NW/4 SW/4 (Unit L) of Section 23 to bottom hole locations in the

SE/4 NE/4 (Unit H) of Section 24; and **El Duderino 23/24 Fed Com #711H (W0DA)** and **El Duderino 23/24 Fed Com #821H (W2DA)** wells, which will be drilled from surface hole locations in the NW/4 SW/4 (Unit L) of Section 23 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 24.

The completed interval of the El Duderino 23/24 Fed Com #824H (W2EH) well will be located within 330' of the half-section line separating the N/2 and S/2 of Sections 23 and 24 to allow for the creation of a 1,280-acre standard horizontal spacing unit.

The completed intervals of the El Duderino Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as the operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
