MOTION TO AMEND PRE-HEARING STATEMENT

1. MRC Case Nos. 26000-26002 are currently set for a contested hearing on August 25, 2026 pursuant to a pre-hearing order issued by the Division on June 18, 2026.
2. COG filed Case 26368 which competes with MRC’s cases.
3. Therefore, the Pre-Hearing Order setting Case Nos. 26000-26002 for a contested hearing on August 25, 2026 should be amended to add COG Case No. 26368, to also be heard on August 25, 2026.
4. Counsel for MRC was contacted and does not object to the motion.
