STATEMENT OF THE CASES

In **Case No. 26158**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 230.23-acre, more or less, standard horizontal spacing unit comprised of the N/2 NE/4, NE/4 NW/4, and Lot 1 of irregular Section 7, Township 20 South, Range 29 East, NMPM, and the N/2 NE/4 of Section 12, Township 20 South, Range 28 East, Eddy County, New Mexico. This unit will be dedicated to the **Jericho 7/12 Fed Com 521H** well, which will be drilled from a first take point in the NE/4 NE/4 of Section 7, Township 20 South, Range 29 East, to a last take point in the NW/4 NE/4 of Section 12, Township 20 South, Range 28 East.

In **Case No. 26162**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 230.72-acre, more or less, standard horizontal spacing unit comprised of the S/2 NE/4, SE/4 NW/4, and Lot 2 of irregular Section 7, Township 20 South, Range 29 East, NMPM, and the S/2 NE/4 of Section 12, Township 20 South, Range 28 East, Eddy County, New Mexico. This unit will be dedicated to the **Jericho 7/12 Fed Com 523H** well, which will be drilled from a first take point in the SE/4 NE/4 of Section 7, Township 20 South, Range 29 East, to a last take point in the SW/4 NE/4 of Section 12, Township 20 South, Range 28 East.

The completed intervals of the Jericho Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as the operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
