STATEMENT OF THE CASES

In **Case No. 26182**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 23 and 24, Township 18 South, Range 30 East, Eddy County, New Mexico. This unit will be dedicated to the **Juice Box 24/23 Fed Com 526H** well, which will be drilled from a first take point in the NE/4 SE/4 of Section 24 to a last take point in the NW/4 SW/4 of Section 23.

In **Case No. 26184**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 23 and 24, Township 18 South, Range 30 East, Eddy County, New Mexico. This unit will be dedicated to the **Juice Box 24/23 Fed Com 528H** well, which will be drilled from a first take point in the SE/4 SE/4 of Section 24 to a last take point in the SW/4 SW/4 of Section 23.

The completed intervals of the Juice Box Wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as the operator of the units and wells, and a 200% charge for the risk involved in drilling and completing the wells.
