STATEMENT OF THE CASES

In **Case No. 26235**, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 1,280-acre, more or less, standard horizontal spacing unit comprised of Sections 27 and 28, Township 21 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Uncle June Fed Com 423H** well, which will produce from a first take point in the NW/4 SW/4 (Unit L) of Section 28 to a last take point in the NE/4 SE/4 (Unit I) of Section 27. The completed interval of the Uncle June Fed Com 423H well will be located within 330' of the half-section line separating N/2 and S/2 of Sections 27 and 28 to allow for the creation of a 1,280-acre, standard horizontal spacing unit.

In **Case No. 26236**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 27 and 28, Township 21 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Uncle June Fed Com 213H** well, which will produce from a first take point in the NW/4 SW/4 (Unit L) of Section 28 to a last take point in the NE/4 SE/4 (Unit I) of Section 27. The completed interval of the Uncle June Fed Com 213H well will be located within 330' of the quarter-quarter section line separating N/2 S/2 and S/2 S/2 of Sections 27 and 28 to allow for the creation of a 640-acre, standard horizontal spacing unit.

In **Case No. 26237**, Permian Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 27 and 28, Township 21 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Uncle June Fed Com 421H** well, which will produce from a first take point in the NW/4 NW/4 (Unit D) of Section 28 to a last take point in the NE/4 NE/4 (Unit A) of Section 27. The completed interval of the Uncle June Fed Com 421H well

will be located within 330' of the quarter-quarter section line separating N/2 N/2 and S/2 N/2 of Sections 27 and 28 to allow for the creation of a 640-acre, standard horizontal spacing unit.

The completed intervals of the Uncle June wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells, the allocation of the costs, the designation of Applicant as operator of the units and the wells, and a 200% charge for the risk involved in drilling and completing the wells.
