**APPLICATION**

Pursuant to NMSA 1978, Section 70-2-17, Permian Resources Operating, LLC (OGRID No. 372165) (“Applicant”) files this application with the Oil Conservation Division (“Division”) seeking to pool additional uncommitted interests under the terms of Division Order No. R-24456. Applicant states the following in support of its application.

1. The Division entered Order No. R-24456 (“Order”) in Case No. 26107 on July 10, 2026.
2. The Order pooled uncommitted interests in the Bone Spring formation, underlying a 643.91-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Section 34, Township 21 South, Range 34 East, and Lots 1 and 2, the S/2 NE/4, and the SE/4 (E/2 equivalent) of irregular Section 3, Township 22 South, Range 34 East, Lea County, New Mexico (“Unit”). The Order dedicated the Unit to the Grama Ridge 3 State Com 4H, Grama Ridge 3 State Com 5H, and Grama Ridge 3 State Com 6H wells (“Wells”) and designated Applicant as operator of the Unit and Wells.
3. Since the Order was entered, Applicant has identified additional interests in the Unit that have not been pooled under the terms of the Order.
4. Applicant has undertaken diligent, good-faith efforts to obtain voluntary agreements from the additional interest owners but has been unable to obtain voluntary agreements from the owners.

5. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, the additional interests should be pooled into the Unit pursuant to the terms of the Order.

WHEREFORE, Applicant requests this application be set for hearing before an Examiner of the Division on October 8, 2026, and, after notice and hearing, the Division pool the additional uncommitted interests into the Unit pursuant to the terms of Division Order No. R-24456.
