JOINT MOTION TO AMEND PRE-HEARING ORDER

The parties to this matter, Mewbourne Oil Company (“Mewbourne”), Permian Resources Operating, LLC (“Permian Resources”), Earthstone Permian, LLC, and COG Operating LLC (collectively the “Parties”) jointly move to amend the existing Pre-Hearing Order currently in effect for Case Nos. 26340, 26342, 26343, and 26344, in order to consolidate Case Nos. 26540, 26541, 26542, and 26543. In support of this motion, the Parties state as follows:

1. Mewbourne filed applications for Case Nos. 26340, 26342, 26343, and 26344 (“Mewbourne Cases”) on July 7, 2026. Permian Resources objected to these cases proceeding by affidavit on July 22, 2026.
2. The Division issued a Pre-Hearing Order dated August 20, 2026, setting the Mewbourne Cases for contested hearing on Tuesday, October 27, 2026.
3. Permian Resources filed competing applications in Case Nos. 26540, 26541, 26542, and 26543 (“Permian Resources Cases”) on September 9, 2026. The Permian Resources Cases have been docketed for hearing before the Oil Conservation Division on Tuesday, October 27, 2026, the same date as the Mewbourne Cases.

4. The Parties have conferred and desire that the Pre-Hearing Order be amended to consolidate the Mewbourne Cases and Permian Resources Cases for contested hearing on October 27, 2026.

WHEREFORE, the Parties hereby request that the Pre-Hearing Order be amended to consolidate the Mewbourne Cases and Permian Resources Cases for contested hearing on October 27, 2026.
